ORDER:

Based on 73rd and 74th amendments to the Constitution of India and the concomitant State Legislations the Fourth State Finance Commission was constituted and submitted its report on 30.09.2011. The Explanatory Memorandum on the action taken by the State Government on the recommendations of the Fourth SFC alongwith its report of the FSFC were placed on the floor of the Assembly on 14.05.2013.

As per Fourth State Finance Commission's recommendation (Chapter XI Para 27 xi) the following criteria and weightages shall be adopted for horizontal sharing of SFC Devolution to ULBs.

- 1) 2011 Census population : 80%
- 2) Area: 15%
- 3) Debt outstanding: 5%

Government, in the G.O. second cited have accorded sanction for the release of Devolution of Fourth State Finance Commission to the Urban Local Bodies in 10 installments on monthly basis from April 2014 to January 2015 as indicated below:

For the months from April 2014 to January 2015:-

Municipalities **Rs.64,17,19,857/- per month** (Rupees sixty four crores seventeen lakhs nineteen thousand eight hundred and fifty seven only)

Municipal Corporations **Rs.98,06,36,928/- per month** (Rupees Ninety eight crores six lakhs thirty six thousand nine hundred and twenty eight only)

Now, sanction is accorded for the drawal of a sum of **Rs.98,06,36,928/- (Rupees ninety six crores six lakhs thirty six thousand nine hundred and twenty eight only)** for the month of **July 2014** towards the devolution amount payable to **Municipal Corporations** as detailed below:
