Based on 73rd and 74th amendments to the Constitution of India and the concomitant State Legislations the Fourth State Finance Commission was constituted and submitted its report on 30.09.2011. The Explanatory Memorandum on the action taken by the State Government on the recommendations of the Fourth SFC alongwith its report of the FSFC were placed on the floor of the Assembly on 14.05.2013.
