Saugeen Ojibway Nation Territory Structure of Leadership:

In the Saugeen Ojibway Nation Territory the selection process of elected positions for Chief and Councilors are based on individuals who are viewed as having the ambition to improving the socio-economic, and business conditions of the First Nations peoples affiliated with the Saugeen Ojibway Nation Territory. When political needs arise for Special Committees the participants are comprised of the members of the Saugeen Ojibway Nation Territory Joint Council, the Elders, Cultural Experts, Technicians, Administrative Support, Research Specialists, Legal Professionals, and Youth Representatives. At such times, the structure of the committee defines their duties and the focus, which is geared to resolving issues that may affect the Rights, Claims and Interests of the members of the Saugeen Ojibway Nation Territory. 6 in favor Carried



On November 15, 2012, a second referendum vote was held in accordance with the *Indian Referendum Regulations* to determine if a majority of the eligible electors of the Saugeen Band ("Band") were in favour of a designation to Her Majesty in right of Canada, in the form attached as Schedule A to this Band Council Resolution, of a portion of Saugeen Indian Reserve No. 29 for leasing purposes;
- B. 177 eligible electors of the Band voted at the second referendum vote and 169 voted in favour of the designation;
- C. On November 15, 2012, the Electoral Officer and the Chief of the Band certified, pursuant to section 40 of the *Indian Act*, that the second referendum vote was held in accordance with subparagraph 39(1)(b)(iii) and 39(2) of the *Indian* Act and that a majority of the eligible electors voting at the second referendum vote assented to the designation;
- D. The *Jobs and Growth Act*, 2012, having received Royal Assent on December 14, 2012, has provisions amending the *Indian Act* to add sections 39.1 and 40.1 to the *Indian Act* which will, when they come into force;
- authorize the Minister of Indian Affairs and Northern Development, not the Governor in Council, to accept the designation; and
- ii. require the Band Council to recommend to the Minister of Indian Affairs

and Northern Development that he accept the designation.

NOW THEREFORE the Band Council, on behalf of the Band, resolves that:

1. It recommends that the Minister of Indian Affairs and Northern Development accept the designation.

DATED February 6, 2013, at a meeting of the Band Council duly convened within the meaning of subsection 2(3) of the *Indian Act*. A quorum consists of five (5) members of the Band Council. 7 in favor 1 opposed Carried

Procedure for getting on the Council agenda.


Please submit your request in writing to the reception desk at the Saugeen Administration Building. Please write "Attention to the Executive Assistant" on your request.

In your request letter be clear and include all details and supporting documentation so that Councilors can be as prepared as possible for your visit or to review your request.

Include your contact information so that you can be informed of the date and time of the Council meeting and where to send the information regarding the decision of Council.

Deputation day is the last Wednesday of the month. The deadline to have your information in is the Friday of the week before Deputation Day.



November 20, 2012

Members of the Saugeen First Nation:

I would like to take this opportunity to congratulate the players, managers, coaches, trainers, parents and the countless volunteers who helped our teams compete and represent Saugeen at the recent LNHL tournament in Mississauga, Ontario. I had the opportunity to see a number of our teams play and I was extremely proud to see the pride, joy and fulfillment of our players throughout the tournament. Well done.

A. Fisheries Agreement

We recently concluded a comprehensive fishing agreement with Ontario. As you know, we have, through the *Jones Nadjiwan* decision (1993), a proven Aboriginal and Treaty right to fish commercially. In the past, the Saugeen Ojibway Nations (Saugeen and Nawash) were successful in establishing successful agreements with the Crown regarding the management of the fishery. The new agreement is premised on reconciliation and ensures the sustainability of our fishery both ecologically and economically. The agreement is available on the Saugeen First Nation website if you wish to review it for yourself in more detail.

There has been a tremendous amount of negative press in recent weeks regarding the agreement. The local MP and MPP have both been extremely critical of the agreement. For the most part, their criticism has been uninformed and has demonstrated a complete lack of understanding for our Aboriginal and Treaty right to fish commercially. As a result, their comments have only helped incite racism and hatred towards our people.

We, collectively with Nawash, have chosen to remain principled in our approach by not engaging in a debate that is uniformed and driven by intolerance and ignorance. As a result, we have gained an incredible amount of support from the general public, elected officials and our respective memberships. We released a statement recently condemning the statements made by the local MP and MPP and ensuing backlash. Our statement makes it very clear that we have a proven and constitutionally protected Aboriginal and Treaty right to fish commercially. It also reaffirms our commitment to work with and educate the general public about our rights and the agreement. A copy of the statement is attached for your review.

In the coming weeks we will continue to keep you apprised of our efforts to implement the agreement and to ensure that our people, rights, interests and way of life are protected. To this end, I would like to thank everyone who came out to our recent meeting to discuss the agreement and the events that have transpired since the agreement was announced. We plan to hold further meetings on this matter in the near future. We will advise you of the date, time and location of the meetings as soon as possible.

B. Eastern Boundary

It has been brought to my attention that there is some confusion as to whether or not the Eastern Boundary claim has been settled. I want to clearly state that the long-standing claim has not been resolved. There is still a lot of work to be done. In the December edition of the monthly newsletter we provided an overview of the claim and the immediate steps that were being undertaken to resolve the claim. From that summary you will know that we instructed our lawyers to get the Eastern Boundary claim back in front of a judge.

We firmly believe as you do that it is time to get this claim resolved once and for all. This is a deeply important issue for our people, restoring our reserve to what was promised in 1854 when we signed Treaty No. 72. For too long we have waited for Ontario and Canada to recognize our rightful claim and correct this historical wrong. We can wait no longer.

Background:

As you know, almost all of the land along what is now called "Sauble Beach" was promised to us in 1854 as part of Treaty No. 72. This land was reserved for us, including the portion of beach just south of the mouth of the Sauble River, because it was a valuable fishery for our people. At the time the Treaty was signed, our reserve land and the surrounding township was surveyed by a man named Charles Rankin. Rankin planted a post at the northeastern boundary of our reserve, roughly 9.5 miles from our territory's southwestern boundary. He also drew a map of the township that records this information. The Treaty, the survey, and the map, all clearly marked the extent of our territory. This was all land that, under the Treaty, was included in the reserve.

The promise was never fully fulfilled. The Governments of Canada and Ontario never recognized an additional 1.5-mile strip of land along the beach as being part of our reserve. Despite the clear evidence of the Rankin survey and the plain language of our Treaty, both Ontario and the neighbouring township refused to recognize this strip of land as ours.

Over the course of the past 150 years we have watched others enjoy the use and benefit of these lands. However, during this time, our people have consistently tried to get the land recognized as ours and put back into our reserve. Finally, in 1990, Canada recognized the merits of our claim and filed a lawsuit on behalf of Saugeen to try and reclaim the land that has always been rightfully ours. In 1995, we decided we could not rely on anyone else to represent our interests, so we (Saugeen) filed our own lawsuit.

Settlement efforts to date:

Since 1995 there have been several attempts to try and reach a settlement on our long-standing claim. In 2006 a mediation was held. Mediation is an attempt to negotiate a fair settlement for all parties, but with the help of a judge. The judge supervises the mediation and helps to identify areas where parties agree, and other areas where further discussion is needed. Justice Winkler supervised our mediation. Justice Winkler worked with all parties and eventually a settlement was proposed that would give us our land and financial compensation. The proposed settlement had a number of problems from the perspective of Saugeen, including a proposal that would continue to grant others a continued right to use the land as they currently are for 99 years.

The proposed settlement was a good starting point, but it needed continued work before it would be acceptable to Saugeen. Saugeen would have to be certain that we would have the same control over this land as we did over the rest of our reserve lands. Chief and Council told its lawyers to negotiate a final settlement with Ontario and Canada that protected our rights and finally resolved this issue.

From 2006 to 2012, Ontario has never responded to Saugeen's attempts to negotiate a final settlement. Ontario has not even agreed to continue negotiating with us. Both Saugeen leadership and our lawyers reached out to both Canada and Ontario on several occasions, but were always told to

wait a little longer, because Canada and Ontario's lawyers needed to get instructions from the government. For six years, Saugeen has tried to get Ontario to resolve this issue. All Ontario has done is ask for more time. Our patience has run out!

Moving the claim forward:

Our Eastern Boundary claim is now back in front of a judge. On November 7, 2012 Chief and Council, accompanied by our lawyers, attended a case management conference in Toronto. A "case management conference" provides a chance for all the parties to get before a judge, explain the current status of the case, and develop a schedule to get the case moving towards trial.

A mediation is scheduled in early May with Canada, Ontario and the municipality of South Bruce. We remain open to a settlement with Ontario and Canada that fully respects our rights. It is our hope that we can achieve this. However, after six years of waiting, we are no longer counting on a settlement to resolve this dispute. If a trial before a judge is the only way for Saugeen to get the land back, then that is what we will and must do. We cannot wait any longer to reclaim this land that has always been ours. Taking the matter to court appears to be the only way to correct 150 years of historical wrong. The work our lawyers are doing will finally get us back our land, to use in the way our people were always promised.

We will be providing a detailed summary of the Eastern Boundary claim so that everyone is aware of and fully understands the claim and related issues. We will also continue to keep you up to date on any new developments with the claim. Together we will achieve justice and, in doing so, honour the sacrifice of our ancestors!

C. Hydro One Negotiations

In recent weeks there has been some confusion regarding our ongoing negotiations with Hydro One concerning the Bruce to Milton transmission line. Some members have approached myself as well as members of council asking if revenues have begun flowing to the community as a result of the our negotiations. I want to be very clear that there is still a tremendous amount of work to be done before our discussions are complete and before revenues will flow to the community.

Background:

By way of background, in 2007, Saugeen Ojibway Nations or SON (Saugeen and Nawash) learned that Hydro One was planning to build a new transmission line from Milton to the Bruce Nuclear site that would follow the route of the existing lines. Since the very beginning, SON insisted that the Bruce to Milton Transmission Line could not go ahead unless SON's concerns about environmental impacts from the line and related generation projects were dealt with, and that SON was provided the opportunity to benefit from the wealth created by the new line.

Convincing Hydro One to meet SON demands has been a long and difficult journey. SON appeared at the Ontario Energy Board hearings, where it convinced the Board that the Line could only be built if SON concerns were addressed. Out of that effort we got the Ontario Government to the table to negotiate the Energy Agreement between SON and Ontario. That agreement recognizes our Traditional Territory and sets up protection mechanisms for the environment and our interests. The Agreement also sets out the expectation that new projects in our Territory would only go ahead if they respected our Rights and interests and SON shared in the wealth generated from those projects.

Anishnaabekiing Naagnigewin Agreement:

The Bruce to Milton transmission project was the first big test of the Energy Agreement and we are pleased to report that real progress has been made. Last year the SON entered into the Anishnaabekiing Naagnigewin Agreement. This agreement laid out the path for SON to become joint owner of the new Bruce to Milton Line with Hydro One – the first of its kind in Ontario.

As an owner, SON will share in the revenues generated from the Line. Those revenues will pay for SON's ownership share. In addition to paying the costs of ownership, profits generated by the line will also create a new source of revenue for each First Nation on an annual basis. This will provide a significant and lasting financial benefit to the SON First Nations as long as the Line is there.

Limited Partnership Agreement:

To formalize the ownership of the Line the SON needs to enter into a Limited Partnership with Hydro One. The Anishnaabekiing Naagnigewin Agreement set out the broad terms of the Limited Partnership Agreement. We, along with Nawash, are happy to report that the Limited Partnership Agreement has now been finalized and approved by both Parties. Just before last Christmas, a ceremony was held in Toronto where the Chiefs, Joint Council and the Board and President of Hydro One approved the Limited Partnership Agreement.

Ontario Energy Board Approval:

The next step in the process is to get Ontario Energy Board Approval for the transfer of the line to the partnership to be owned by SON and Hydro One (as is required by law). While this is going on we will be taking the steps to get all the financial pieces in place, so that we will be able to take our full ownership and begin our sharing of the wealth as soon as the OEB gives its approval.

The Ontario Energy Board Approvals have now been submitted to the Board and we are waiting for them to be considered. SON will participate in those hearings to ensure that our interests are protected.

When will the revenues flow?

The Agreements are all ready to go, but we have to wait until we get approvals and finish up the financing before SON will start to earn is share of the revenue. We are hoping that the Board will give its decision before the end of the year and that we will be able to start to earn funds early in 2014.

Our First Nations will have to determine how to put these new revenue sources to work in our communities and to determine how we will invest them for the future. None of the revenues have flowed to the communities, been spent or committed.

It has been hard work to get to this point and there is still a lot of work to be done, but we are confident that we will succeed. We will continue to bring this issue back to the community, as the work progresses, to keep you up to date and get your feedback.

The Chief and Council extend an open invitation for you to sit in on our regular council meetings, which are held every Wednesday. I also encourage you to drop by the Band office during regular office hours if you have any questions or concerns. My office door is always open.

I am proud of our Nation. The responsibility lies with all of us to build a strong Nation as well as to advance and protect our rights and interests. Through unity comes strength and the voice of the people shall always govern!

TAKING THE HIGH ROAD: THE SON/MNR FISHING AGREEMENT

"....we have achieved success by maintaining the high road, sheer determination and perseverance...."

The Late Chief Ralph Akiwenzie, Ipperwash Inquiry 3 September 2006

We have a duty to protect our people. We have faced racism, ignorance and violence. In the wake of these challenges, we have maintained the high road. Over the last several weeks, The Saugeen Ojibway Nation ("SON") has declined to respond to visceral and uninformed reactions to the SON/MNR Fishing Agreement. We were waiting for the appropriate time to respond publically to these reactions. This is that time.

On February 25, 2013, SON entered into a Substantive Commercial Fishing Agreement ("the Agreement") with the Government of Ontario (MNR). Following its release, MP Miller referred to the Agreement as a "mess." He also reported that he received calls about the potential for violence. Did he report these threats of violence to the police? We do not know. We put the police on alert. MP Miller and MPP Walker also issued a joint press release referring to the Agreement as an "insult." These actions, by individuals who, as elected officials, are bound to uphold the rule of law, have ignited negative and uninformed public reaction to the Agreement. Mutual trust and respect have suffered.

But our reply to the critics is simple. SON has proven existing aboriginal and treaty priority rights to fish for commercial purposes within the waters of Lake Huron and Georgian Bay protected under s. 35 of the *Constitution Act, 1982*. These waters also include Owen Sound Bay and Colpoys Bay. These rights were recognized on April 26, 1993 in *R. v. Jones and Nadjiwon*. That decision was both an end and a beginning. It *ended* 150 years of exclusion of our people from the fishery. It was the *beginning* of the reclamation of our rights over the fishery. Perseverance is required to overcome the adverse effects of exclusion. Determination is required to educate others when they are uninformed.

We will never forget the past, but we will build a better future. This Agreement is a step toward reaching that goal.

It has been said that our people are being paid to fish. This is nonsense. In 1999, the Ontario Conservative Government paid non-aboriginal fishermen \$15.8 million not to fish in our Traditional Waters by "retiring" their licenses. This was in addition to a prior payment of \$7 million. Paying a total of \$22.8 million dollars to non-aboriginal fisherman not to fish pales in comparison to the \$850,000.00 (spread over 5 years) allocated under the Agreement for the assessment and the setting of safe harvest limits, based on sound science, to ensure conservation of the resource. We are not being paid to fish. Unlike non-native fishers, who derived millions of dollars from the fishery over the last 150 years, our people have not been compensated for their exclusion, to the benefit of others, from our Traditional Waters.

This Agreement, as well as those that preceded it, are based on a simple principle: the sustainability and conservation of the fish and the waters, which support the fishery, is paramount. It is our collective duty to protect the waters in which we have fished from time immemorial.

SON understands the importance of the recreational fishery. This Agreement will not decimate it. Rather, the Agreement provides new and flexible mechanisms so that we can work together with Ontario to protect the waters and ensure safety on them. Achieving these goals requires commitment, capacity, resources and determination. We will work with Ontario and other government agencies to implement the Agreement and the commitments contained within it. Both SON and Ontario called upon Canada to participate in negotiating this Agreement. Canada refused.

Rather than condemning the Agreement, people should see the opportunities contained in it to build upon the principles of mutual trust and respect. Words of condemnation, uttered without a full understanding of the past and the Agreement, serve no purpose but to incite violence and misunderstanding.

For those that truly want to understand the history of SON and the Agreement, you may wish to read our submissions to the Ipperwash Inquiry. It tells the story of our people and our fishery. We also ask those who have condemned the Agreement to read these submissions. If the critics truly are interested in mutual trust and respect, and the sustainability of the waters, they will take the time to learn about how we can work to overcome the past and protect the waters in the future. The waters and the Bays are sacred to us. Our people have fished in these waters from time immemorial. We will continue to do so. The Agreement provides a mechanism by which we can all safely co-exist. Time will tell whether critics of the Agreement will open their minds to this possibility.

An Eye On Council with Sonya Roote - April 2013

Hello everyone! It's been another busy month and I would like to share some of the issues that Chief and Council are working on:

- 1. DGR (Deep Geological Repository) The issue of burying high level nuclear waste in our territory is something that Chief and Council are standing very firm on. Although there has not been any formal announcement that this is the final plan for the proposed DGR, we believe that this is the outcome that is planned. We are now in the process of trying to meet with the 'big wigs' of this project. At the moment, our voice doesn't seem like it's being heard. However, we will continue to be loud and clear that SON will not stand idly by while others try to make decisions on the future of our territory. Our voices will be heard.
- 2. Hiring Process As reported earlier, Chief and Council have passed a new hiring process for employment. This process puts the hiring into the hands of the Administration. The Hiring Committee is comprised of; the Band Administrator, Human Resource Manager, Employment and Training Officer and the appropriate Program Manager. The committee does all of the 'leg work' such as, applications, screening and interviews. The committee uses a point system to make the final decision and then recommends the decision to Chief and Council for final approval.
- 3. East Boundary Claim We have a mediation in Toronto on May 1st and 2nd to see if we can get the claim agreed on and finalized without taking it to litigation. The mediation will consist of: lawyers for Saugeen, Canada, Ontario and the Township. Any proposed settlement will be brought back to the community to make the final decision. I would like to emphasize that no monies have been paid to Saugeen in regards to this claim. When the time comes, Saugeen members will decide on where any settlement money will be spent.
- 4. Hydro Transmission Line I know that I have reported earlier that this agreement is not yet finalized. We are hoping that all goes well and that SON will officially be 33% owners of this line by the end of 2013. Once again, if and when any funds come to Saugeen at that time, the people of Saugeen will have the responsibility to decide what these funds will be used for. No money has been received yet in regards to this project.

I would like to remind everyone that our Human Resource Manager, Tina Jacobs, takes her direction from the Band Administrator, Personnel Committee and, ultimately, Chief and Council. She is not making the decisions regarding the hiring process or the minimum requirements for job postings. I understand that many people are unclear or upset about the new process. I know that change is hard but these changes have been made in the best interest of all Saugeen Members. It is a learning process and I would ask that we be patient – especially with staff members who seem to take the brunt of the backlash for changes. On that note, I would like to say thank you to Tina Jacobs for working so hard at a very difficult job. I know that we hand Tina many difficult tasks to complete and her dedication really shows. Keep up the good work Tina!

Stay tuned for more updates and, as always, feel free to contact me if you have any questions or concerns that need to be addressed at Council. Let's do this! Meeg-wetch!

NOTICE

TO ALL GAS EXEMPTION CARD HOLDERS

We have been having some complaints regarding our Gas Exemption Purchases so I am posting this notice so you are aware of the procedures that we have to follow.

As this is Point of Sale, this means when you come for gas, to get the taxes taken off you must present your gas card upon purchase. You cannot ask the cashier" Can I come back, I left my gas card at home "This is necessary to clear the purchase from the Register; if we cannot do this then we cannot pump gas on this pump until the purchase has been paid. As this system has been in place since August of 2011, everyone should be familiar with it, so when you come for gas make sure you have your gas card. If for some reason your card does not work, we will work to find out why, it could be expired in which case you will have to apply for another one, these are available at the Gas Bar or see Samantha Johnson in Membership. Another reason could be that it was reported lost or stolen or you have applied for a second one, in which case your first card will not work as the Ministry will not recognize two gas cards for one cardholder. These usually take a week to come in the mail; in the meantime have your spouse bring your vehicle in and they can use their card, this is the only exception for signing other than signing for children under the age of 16. You need to be in the vehicle to sign for tax-free gas.

As these cards are the Property of the Ministry of Revenue, the below are conditions of use:

- 1. Only the person named on this certificate may use it to purchase gasoline tax exempt
- 2. Tax-exempt gasoline may not be supplied
 - a) By other than a dealer specifically authorized to do so
 - b) In bulk except on to the reserve of the holder of this card
 - c) Directly to a motor vehicle except on the reserve
 - d) For re-sale
- 3. This certificate shall be presented to the retailer at the time of each gasoline purchase, Please Note: An imprint is no longer applicable as we now scan the cards.
- 4. <u>Misuse and fraudulent use will result in cancellation of the Certificate of Exemption</u> and or the authorization of the dealer and may result in charges being laid under the Criminal Code.
- 5. The rights, beliefs and principles of an individual card holder are not jeopardized by acceptance of this card, the use of which is intended solely as a means of participation in the tax-exempt program administered by the Motor Fuels and Tobacco Branch for the benefit of aboriginals.
- 6. This certificate shall not be left with the retailer or any other person.

I encourage anyone who does not possess a Certificate of Exemption Card to apply otherwise you will be required to pay the tax. Please do not take it out on the staff, they are only following procedure.

Our Hands at Work!

The hand is the part of the body most often injured and these injuries are sometimes difficult to heal. Hand injuries are preventable.

Think of your hands as...

Valuable

Your hands are superbly designed tools of amazing strength and dexterity. They can pinch, grasp, twist, lift, hold and manipulate while doing a wide variety of other specific tasks.

Vulnerable

Your hands and wrists are a complex system of bones, muscles and tendons, ligaments, blood vessels and nerves protected by layers of skin.

The skin provides a barrier against chemicals, heat and cold. The skin on the back of the hand is thin and elastic and, on the palm, it is thick to provide traction, cushioning and insulation.

Remember! Your hands are valuable but also vulnerable! Even if a small cut makes it difficult and painful to work or play, imagine if you had a serious injury.

Hand Injury Prevention

- Work at your own pace. The frequency of hand injuries is proportional to how quickly you work.
- Stay Alert! Always watch what your hands are doing.
- Wrenches should properly fit nuts and bolts.
- Use gloves appropriate for the job and temperature.
- Let hot surfaces cool before working on them.
- Use hand rails on stairs.
- Use safe handling techniques.
- Keep your hands and fingers away from cutting tools.
- Always obtain first aid for every injury, no matter how minor!



2012 Summary Report

In 2012, we seen a total of 8 injuries were reported to the Health & Safety Committee. Of these 8 injuries, 7 of the injuries resulted in WSIB Claims and the one injury did not result in losing any time from their work schedule.

Protect your Back!

Doing things as simple as carrying a parcel, driving your car or bending over to tie your shoes can cause you to feel sudden back pain. Your back locks up and you're immobilized, unable to straighten up or make the slightest movement.

A few weeks of rest is usually all it takes for your back to recover but sometimes more drastic treatments are required such as traction and surgery. Some people never recover. They are left with a permanent disability and from then on are unable to perform any strenuous work involving their spine.

Back Injury Prevention and Tips

- Pick up Garbage and debris that could get in the way
- Always use proper material handling equipment
- Avoid handling objects on stairs
- If you are not used to exertion, do not lift over 23 kg (50 lbs)
- Ask for assistance if loads are too heavy
- Do a muscle warm-up before starting to work.
- Decrease the weight of objects handled
- Learn and apply safe lifting techniques
- Avoid handling objects on stairs
- Never exert yourself unnecessarily
- Use personal protective equipment, such as belts, braces, leg guards and anti fatiguing matting



The Bruce Peninsula Ontario Provincial Police (OPP) investigated several 911 hangup calls in March. These calls were unfounded and did not require Police attendance. The OPP wants to remind everyone that when a 911 call is received, the Police MUST attend and investigate the call to determine whether or not it is valid.

Officers from the Bruce Peninsula OPP investigated several motor vehicle collisions throughout the month. One occurrence resulted in charges being laid against a Saugeen First Nation man for failing to report a motor vehicle collision. The remainder of the calls involved collisions with deer. The OPP reminds motorists that with deer leaving their winter yards, they will be along the roadside in search of minerals and salt residue from the winter.

Members of the Bruce Peninsula OPP received several animal-related calls during the month, one about a raccoon that was acting strange. At this time of year a lot of animals are out and about after a winter of hibernation. They may act strange, appear thin, and be out in the daylight. This does not mean they have rabies, mange, or distemper. Should there be concerns for the safety of residents regarding such animals, Police should be contacted.





Never a Dull Moment in Cat Lake First Nation


Cat Lake First Nation may be a small community, but as Community Mentor Joyce Peters makes clear, there is "always something to do... we never run out of ideas." Recently, the youth in her Youth Leadership Program organized a Winter Carnival that drew over 90 kids and staff members from the local school. With kids taking part in sliding, snow shoeing, broomball, inuksuk sculpture and toffee making it was nothing but smiles: a sight that makes Ruby Keesickquayash, Principal at Titotay Memorial School, "happy...because when the kids are happy I am happy."

YOUth LEADing the Way

Over the March break, 40 youth delegates from various Indian Friendship Centres came to attend the Ontario Federation of Indian Friendship Centres' (OFIFC) YOUth LEADing the Way Forum. During the forum, Right To Play and the OFIFC partnered to co-facilitate a day-long Youth Leadership Workshop. The workshop focused on building leadership capacity in youth and encouraged the youth delegates to promote lasting change in their communities. The Forum helped them identify pressing issues in their communities as well as possible strategies to address these issues.

March Break Cultural Camp in Saugeen First Nation

Over the March break Community Mentor April John worked with Saugeen First Nation's Cultural Department to facilitate a cultural camp. The week-long camp featured a beading workshop, art workshop, survival skills workshop (where youth learned about hunting and fishing rights as well as how to light a fire outside in the winter) and much more. Over 40 kids showed up along with approximately 30 community members.



Challenges and Success in Nipissing First Nation

Zan McLeod is the Community Mentor in Nipissing First Nation. He runs the Youth Leadership Program (YLP) four times a week and reaches up to 30 youth each week. Like many other Community Mentors, Zan encounters a variety of challenges (such as securing venues, dealing with inconsistent turnouts and competing with other programs) while delivering the YLP. However, through a combination of hard work and resourcefulness Zan has found ways to deal with these challenges and ensure his program reaches the youth.

For starters, Zan ensures he maintains a profile within the community by participating at local sporting events. This provides Zan with the opportunity to connect with youth in the community and tell them about the YLP he runs. Secondly, he has reached out to members of his community for support. School administrators have provided him with the opportunity to run programming with the youth following their volleyball practices. As Zan explains, "kids were there for an extra hour waiting for rides, so it was a perfect time to occupy them with the YLP." Finally, he has never lost sight of the fact that you have to keep the youth in mind. Many of the children in his program are interested in working out and playing football, so Zan has adjusted the program to their interests. He helps some of them in the gym with their workouts by providing them with tips on their nutrition and routines. By focusing on these three principles Zan has overcome various challenges and ensured he is able to draw youth to his program.

Energizer of the Month: 'Fruit Salad'

Divide participants into
three to four groups with
an equal number of members. Label each group a
particular fruit.

Have everyone sit in a circle on chairs and ask one person to stand in the middle of the circle. When you shout out a fruit all the participants who have been labeled that fruit must get up and switch chairs with another member of the same fruit group. The person in the middle must try to take the place of one of the people switching chairs. There should be one person left standing without a seat. The new person in the middle calls out a fruit and repeats the process. If you scream 'FRUIT SALAD' everyone must get up and switch




