## 1 Proposed character

## 2 Description

The  $\ensuremath{\mathfrak{G}}$  is used in Nandinagari for nasalization in Vedic texts. As it is related to other Vedic nasalization signs, it is proposed for inclusion in 'Vedic Extensions' instead of a future Nandinagari block. It has been assigned the name VEDIC SIGN DOUBLE ANUSVARA ANTARGOMUKHA because it consists of two instances of  $\ensuremath{\mathfrak{G}}$  U+1CE9 VEDIC SIGN ANUSVARA ANTARGOMUKHA stacked vertically. It is a letter-like character that can function as a base for a combining nasal sign. It occurs in the syllable  $\ensuremath{\mathfrak{G}}$   $\$

The character should be extended for use with the proposed script 'Nandinagari' in ScriptExtensions.txt.
