

# **About the College**

Welcome to Andaman Law College, a prestigious institution established with a vision to provide exceptional legal education and foster the growth of legal minds. Andaman Law College, located on the picturesque island of Andaman, has emerged as a prominent centre of excellence in legal studies. It came into existence in the year 2016 under the aegis of Andaman and Nicobar Islands Legal Education Society (ANILES) registered under the Societies Registration Act, 1860, fully funded by the A & N Administration & governed by its own rules and regulations. The ANILES is chaired by Hon'ble Lieutenant Governor of A & N Islands as President of the society and the Chief Secretary and Commissioner-cum-Secretary (Education, A & N Administration is the Chairman and Vice-Chairman of the Executive Council of ANILES respectively.

The college is recognized by the Bar Council of India and affiliated to the prestigious Pondicherry University. The institution offers a full-time B.A.LL.B. (Five Years – Integrated Course) Degree Programme designed to impart a strong foundation in legal principles, constitutional law, criminal law, contract law, and more. To ensure the high-quality education, the course is taught by the experienced faculty members selected by strictly adhering to the BCI and UGC regulations. At Andaman Law College, education goes beyond classrooms and the students are encouraged to participate in extracurricular activities, moot court competitions, debates, legal workshops and seminars. These activities help students develop practical skills, critical thinking abilities and improve their overall personality. The college is equipped with state-of-the-art facilities to enhance the learning experience. The library houses an extensive collection of legal resources, including books, journals and online databases. Smart Classrooms, Moot Court, Computer Lab and a well-equipped auditorium provide students with a holistic learning environment.

The college at present housed in Transport Bhawan owned by the Government till a new campus is built with all the necessary modern facilities and infrastructure for Andaman Law College. Sincere steps are being taken to get land allotted for Andaman Law College. Moreover, the proactive approach and commitment of the A & N Administration and the collective efforts of the officials, faculty members and the administrative staff, the Andaman Law College will soon emerge as a model Law College and become visible in the map of legal education in India within a few years.

#### **Objectives**

The primary aim of Andaman Law College is to provide legal education, legal services and research in the field of law, in Andaman & Nicobar Islands. In order to attain these objectives, the society would aim:

- a. To work as a service organization for setting up, running and maintaining of Law College and providing Legal Service in A & N Islands.

Joint Secretary (Hr. Edn.) / Director (Education) shall be the Member Secretary of the Finance Committee.

## **Programme Offered**

The Andaman Law College is affiliated to Pondicherry University and approved by Bar Council of India and is currently offering B.A.LL.B. (Five Years – Integrated Course). This course has been designed taking into account the standards prescribed by the UGC and the Bar Council of India and is comparable to the syllabus prescribed by the leading universities in India/Law Schools with regard to the Five-Year Bachelors' Degree Programme in Law.

## **Eligibility Criteria**

The BCI being the regulating authority for legal education in India has prescribed the following eligibility criteria for getting admission into the B.A.LL.B. (Five Years – Integrated Course) Degree programme:

A candidate for admission in the B.A.LL.B. (Five Years – Integrated Course) should have:

- a. Passed the Higher Secondary School Examination (10+2) conducted by CISCE/CBSE/ any State Government Board or equivalent recognized by Pondicherry University securing not less than 45% marks in the aggregate in the case of general category and 40% marks in aggregate in the case of SC and ST candidates.
- b. Not completed 20 years of age in as on 1<sup>st</sup> July of the year of admission. In case candidates belonging to ST/OBC, they shall not have completed 22 years of age as on 1st July of the year of admission.

Consequent on passing of interim order by the Hon'ble Supreme Court staying the age limit for law admission prescribed by BCI, others may also apply. However their admission will be subject to the outcome of the final order to be passed by the Hon'ble Supreme Court.

Provided that such a minimum qualifying mark shall not automatically entitle a person to get admission into an Institution but only shall entitle the person concerned to fulfill other Institutional criteria notified by the Institution concerned or by the government concerned from time to time to apply for admission.

Candidates with compartment/supplementary in any subject in the qualifying examination will not be eligible for admission.

**Note:** Candidates who have obtained (10+2) through Open University systems directly without any basic qualification (passing X Standard in regular stream) are not eligible for the admission.

#### Student Intake and Rules of Reservation

The intake of students for admission is limited to 40 as approved by Pondicherry University. Seat reservation/allocation of seats will be strictly as per the prevalent Rules and Regulations of Government of India and A & N Administration from time to time. In the event of changes, if any, in the allocation of seats for various categories, the same will be intimated before counseling of students through the website of A & N Administration, college website and in the local daily. However, at present the seats are allocated in the following manner:

#### 10% Reservation for Economically Weaker Sections

Candidates belonging to the Economically Weaker Sections intending to seek reservation under EWS Category should submit the certificate issued from the Revenue Department. In case of non-receipt of reply, the seats will be allocated from the existing number of seats and the 10% seats of EWS will be provided from the existing unreserved categories as per the guidelines of the A & N Administration.

### Reservation for Divyang (Person with Disability)

5% seats are reserved for PWD candidates on interlocking reservation basis i.e. horizontal reservation cuts across vertical reservation since the PWD candidates have to be placed in the appropriate category. To qualify for selection under PWD, such a candidate should have 40% disability and above, duly certified by the Competent Medical Authorities under the provisions of Persons with Disability Act.

The various categories as specified earlier, can be claimed by attaching the certificate as per the Annexure detailed below. The candidate, who obtained such certificates previously, may submit the same and they need not obtain the certificate afresh.

Category - I

**Tribal** 

Certificate as per **Annexure I** duly signed by Tehsildar of the jurisdiction to be attached to support the claim of the candidate.

Category - II

Wards of Central Govt. Employees & those on deputation with transfer liability.

Central Government Employees & those on deputation with transfer liability to serve outside the Union Territory provided their wards have studied the last two years in the Islands and passed the qualifying examination from a school in the Islands. Certificate as per **Annexure-II** duly signed by the competent authority of the concerned department to be attached to support the claim of the candidate.

Category - III

Pre-1942 settlers & those who were settled under various rehabilitation schemes introduced after re-occupation of Island.

Certificate as per **Annexure-III** duly signed by the Tehsildar of the jurisdiction to be attached to support the claim of the candidate.

Category - IV

Wards of Locals & Central Govt. Employees (who do not fall under category – I, II or III) having no transfer liability to serve outside the Union Territory, provided their wards have had 10 years education in the Islands.

Certificate as per **Annexure-III** duly signed by the competent authority of the department concerned, to be attached to support the claim of the candidate.

Category - V

General merit quota

Open to all residents of Andaman and Nicobar Islands, subject to the condition that their wards should have studied the last 02 years in the Islands and passed the qualifying examination from a school in the Islands. Class XII certificate to be attached to support the claim of the candidate.

#### **Differently Abled Persons**

The candidates will be required to submit a valid disability certificate from the competent authority issued not more than 03 months prior to the counseling/admission date. The certificate as given in **Annexure-IV** must indicate the nature and extent of physical disability. No certificate other than this shall be accepted for claiming the seats reserved for Divyang. Provided that the seats reserved for the Divyang remain unfilled due to the non-availability of eligible candidate(s) under this category, the same shall be treated as unreserved. The provisionally selected candidate in the Divyang Category will be examined by a Special Medical Board constituted for this purpose by the Administration, and the decision of the board shall be final.

#### Other Backward Class Candidates

OBC candidates claiming relaxed eligibility criteria as indicated earlier must submit a certificate as per **Annexure-V** duly signed by the Tehsildar of the jurisdiction.

#### **Duration of Semester**

Each Semester shall not be less than 15 weeks duration with not less than 30 class hours per week including tutorials, moot court exercise and seminars provided that there shall be at least 24 lecture hours per week.

#### **Attendance**

- a. The duration of one period of general class shall be at least for 60 minutes.
- b. A candidate in order to qualify himself/herself to appear the semester examination shall have to secure at least 75% of classroom attendance in each paper of that semester.
- c. A candidate who represents the Institution in any International/ National/State Level Academic Sports Competition with prior permission of the Principal shall be awarded with 15% classroom attendance during that Semester.
- d. A candidate, who has secured 60% to 74% of classroom attendance due to illness, may submit medical certificate from a registered medical practitioner for adjustment of deficit attendance.
- e. The Principal shall have the prerogative to award 10% of classroom attendance to a candidate.

#### **Facilities**

#### **Smart Classroom**



A smart classroom is an Ed Tech-upgraded classroom that enhances the teaching and learning process for both the teachers and the students by inculcating audio, video, animations, images, multimedia etc. This increases the engagement factor and leads to better-performing students. Andaman Law College is well equipped with smart class

rooms to facilitate the teaching learning process and thereby encourages collaborative learning.

#### Library

Library is the 'heart' of any academic institution and plays an important role in all academic activities. The library has been planned to keep in view the aims and objectives of the Andaman Law College and is being maintained by professionally qualified library staff .It has a collection of over 3029 books covering wide range



general and special subjects comprising of textbooks, reference books, back volumes of journals, reports etc. apart from current legal periodicals. The library functions from 09:00 am till 05:00 pm on all working days of the week.

The library has an open access system to facilitate the students to have access to library resource. To assist the students in locating literature as well as information in the areas of research, an orientation programme is also organized for the fresher's to help the acquaint themselves with the library system and for enabling maximum utilization of the available resources. Efforts are being taken to introduce computerized facilities for both housekeeping as well as information retrievals. Keeping in mind the vision to create e-library, the Andaman Law College subscribed to many online databases which contain enormous resources available for both students and faculty. With the computerized library system, it is the aim of the library to establish a network of law libraries in India in collaboration with leading National Law Schools in India.

Our efforts in building and updating the collection will continue unabated. Every year the Administration is committed to add adequate titles to our collection to meet the demands from curricula.

#### **Computer Lab**



The campus is Wi-Fi (wireless-fidelity) enabled. The computer lab has 15 high end desktops with Microsoft Operating system well equipped with optical drive. The lab is supported by one server with a high-speed bandwidth hand printing facility. Efforts are being taken to procure more desktops to cater the needs of the students to be

admitted in the subsequent academic years. The Computer Lab is managed by a team of well qualified and professionally trained staff.

#### Reading Room

The students of Andaman Law College are provided with the facility of a reading room where one can read newspapers, magazines, books, etc. they are interested in and where they feel comfortable and welcomed. It also helps to build confidence, develop literacy skills, and promote a positive learning community.

#### **Moot Court**

Moot court activities are a thrust area of legal education which forms a yard stick to measure the rating of the legal institution. It integrates the theory and practice of law in campus settings. It trains the students to build their skill of advocacy before they step into the legal practice. Andaman Law College has a



well-built moot court hall. A moot court committee consisting of faculty members constantly motivates the students to participate in the mooting activities. Andaman & Nicobar Administration is generous in resolving that in every academic year maximum of six teams comprising of three students in each team may participate in the Moot Court competition to be held in Law Colleges/ Universities in mainland and each team shall be escorted by two faculty members. The expenditure incurred for the same shall be reimbursed in accordance with the Govt. of India norms. Moreover, Andaman Law College plans to organize national level moot court competition by inviting teams from other Law Schools/Universities/Colleges in the mainland India.

#### **Physical Education and Sports**



As a healthy mind requires a healthy body, since its inception, the Andaman Law College has evinced keen interest in providing sports facilities for the students and sincere efforts have been made to impose such facilities. At present, the college has indoor facility for table tennis, carom, chess and

ball badminton. In collaboration with the JNRM, students are enabled to utilize the outdoor facility for football, basketball, volleyball, cricket etc. The students are encouraged to participate in the inter-collegiate, university, state and national sports events.

#### **Legal Aid Clinic**

Legal Aid Clinic aims to provide free legal services to the poor and needy, creating awareness among the people about their rights and facilitating easy access to legal assistance to them. Keeping in mind the aims of Andaman Law College, Legal Aid and Lok Adalat proceedings are incorporated as part of the curriculum. A Legal Aid Centre was



inaugurated in Andaman Law College by the Judges of the Circuit Benches of Calcutta High Court at Port Blair and the needy and poor people of the island may approach the center on every Wednesday for free legal advice/assistance. In collaboration with the District Legal Services Authority (DLSA) in A&N Islands, the steps are taken to imbibe a sense of social responsibility in the mind of the students' to engage in this noble cause.

#### **Students Internship Programme**

The internship programme attempts to expose the students to understand how law works in practice. It aims to teach professional skills and ethics and trains them to manage the challenging situation in practical and professional life. Internship may be undertaken in lawyers' chambers, courts, corporate establishments, legal aid centers, NGOs, Government Law Offices etc. The internship programme is facilitated from the 3rd year of B.A.LL.B. course and is co-ordinated by internship committee consisting of the faculty members. On completion of the internship programme, each student is required to submit a report along with the certificate issued by the competent authority of the interned office. Andaman Law College is committed to provide a fair opportunity to all its students to learn the nuances of legal practice while they study law. The internship will be arranged by the college by liasoning with these organizations and finding out the requirements of the organization and the expectations of the students. Our mission is to produce the socially responsible lawyers. Social responsibility cannot be taught, it has to be learnt.

#### Student and Faculty Exchange Programme

Andaman Law College has initiated steps to sign Memorandum of Understanding (MoU) for exchange of students and faculty with some of the leading National Law Schools in the mainland. Some Law Universities and Law Schools in the mainland have shown keen interest for such programmes with Andaman Law College and the process of signing the MoU is expected soon. This programme will facilitate not only the students of Andaman Law College to undergo their legal study at other Law Schools for one full semester but also the faculty members to learn the modern innovative techniques of teaching and develop legal knowledge in the most developing subjects. The faculty members of reputed National Law Schools have been invited to deliver special lectures on subjects of current importance.

#### Hostel

Currently, the Andaman Law College has no hostel facilities. The interisland students who are eligible for hostel facility are given a stipend of Rs.1500/- per month to meet their mess expenses, at par with the students of other colleges of the Islands. However, the eligible students from inter-islands are provided accommodation at DIET Hostel, Garacharma as per the availability of rooms.

#### **Decorum and Dress Code**

Students are expected to dress decently inside and outside the campus. They should follow the dress code prescribed as below on all the working days:

Boys: White Shirt, Black Trouser, Black Tie, Black Shoes and White Socks

Girls: White Kameez, Black Salwar, Black Coat, Black Shoe and White Socks

#### **Conduct and Discipline**

Andaman Law College is committed to promote good conduct and discipline among the students. As it is well said, "Education without character is not only wasteful but also dangerous to society", the value of conduct and discipline will be imbibed in the minds of the students. It is expected from every student that he/she must conduct himself/herself with discipline, decency and dignity both on and off the campus. Undignified behavior with students, administrative staff or faculty members will be seriously viewed. The students are supposed to follow the dress code.

#### Ragging

Ragging in any form is strictly prohibited on and off the college campus. Any one indulging in ragging is liable to disciplinary action and to criminal prosecution under the relevant laws.

UGC Directives defining and prohibiting ragging are as follows:

#### 1. Definition of Ragging:

Any disorderly conduct whether by words spoken or written or by an act which has the effect of teasing, treating or handling with rudeness any other student, indulging hardship or psychological harm as to raise fear or apprehension thereof in a fresher or a junior student or asking the students to do any act or perform something which such student will not in the ordinary course and which has the effect of causing or generating a sense of shame or embarrassment so as to adversely affect the physique or psyche of a fresher or a junior student [Raghvan Committee Report, 2007, Para 3.19]

#### 2. Prohibition of Ragging:

Ragging is strictly prohibited inside and outside the education institution.

#### 3. Penalty for Ragging:

Whoever directly or indirectly commits, participates in, abets or instigates ragging within or outside any educational institution shall be suspended, expelled or rusticated from the institution and shall also be liable to fine which may extent to Rs.10,000/-.The punishment may also include

- i) Cancellation of admission,
- ii) Suspension from attending classes,
- iii) With holding/withdrawing fellowship/scholarship and other financial benefits, with holding or cancelling the results. Provided that except suspension, a student may be expelled only after an opportunity of hearing is given to such student. The enquiry in this regard shall be completed within a period of two weeks. Provided further that if such ragging take place during the course of any test or examination such student may be permitted to undertake the test or examination but their result shall be subject to any decision which may be taken in that

regard. Suspension may be resorted forthwith having regard to the nature of the complaint made or information received by the Head of the Institution or from a warden of any hostel or member of the proctorial staff or any other person. The decision to suspend or expel or other punishment shall be taken by the Head of the Institution.

#### 4. Deemed Abetment:

If any member of the staff responsible for the management of the institution or its hostels neglects to take action, shall be deemed to have abetted ragging. In such a situation, disciplinary action may be taken against such member of the staff.

#### 5. Undertaking:

As per the Hon'ble Supreme Court & UGC/MHRD, every student and the parent/guardian shall fill in an online Anti-Ragging Undertaking at www.amanmovement.org (or) www.antiragging.in and they shall submit the hard copies to the Head of the Institution at the time of admission and for every semester till the course completion to the effect that she/he shall neither indulge himself/herself or instigate any other student in ragging or create nuisance to the academic atmosphere of the Institution.

Head of the Institution shall be responsible to take immediate action on receipt of the complaint/information about any instance of ragging and shall dispose of the complaint expeditiously, not exceeding two weeks. The inquiry may be conducted by the Head of the Institution himself or through his nominee or nominees. The Head of the Institution/Warden of the hostels should immediately lodge an FIR in respect of offences regarding which action may be taken under the Indian Penal Code. The aforesaid action would be in addition to and not in lieu of the disciplinary action which may be taken by the Institution.

#### **Sexual Harassment**

Sexual Harassment is now considered as a violation of the fundamental right to equality of a girl as guaranteed under Article 14 and 15 and the right to life and to live with dignity as per Article 21 of the Constitution of India. The definition of sexual harassment in the Act of 2013 stipulates that a girl shall not be subjected to sexual harassment at any place. As per the statute, presence or occurrence of circumstances implied or explicit promise, interference with work or creating an intimidating or offensive or hostile

environment or humiliating treatment likely to affect the girl's health or safety may all amount to sexual harassment. With the enactment of the Sexual Harassment of Women at Workplace (Prevention, Prohibition and Redressal) Act, 2013 Andaman Law College will constitute an Internal Complaints Committee very soon.

So far, no complaint of sexual harassment in Andaman Law College has been received. However, the committee is ever vigilant to ensure the safety of women on the campus and has taken up the issue of making the students aware of their rights through setting up of open forum, talks and discussions from time to time.

Anyone found guilty of sexual harassment of any girl will be immediately expelled from the college and the case will be handed over to police to be dealt as per the law.

#### Every student should be aware of the following misconducts:

Ragging and eve-teasing.	Possession of any kind of weapon.
Smoking, chewing pan, use of any type of tobacco products, and spitting in and around the college premises	Leading, organizing, assisting or participating in any kind of strike without prior notice.
Use of mobile phones in classrooms and seminar halls.	Displaying any kind of notice without the permission of the Principal.
Disrupting faculty members' in discharging their duties.	Participating in any kind of political activities in the college campus.
Defacing classrooms, electrical fixtures and college property.	Possession or use of intoxicating beverages or illicit drugs in the college campus.

Any student against whom a charge of misconduct has been proved, he/she will be punished. Such punishment may be in the form of reprimand or warning, suspension or expulsion from the college, suspension from campus privileges for a fixed period and any other disciplinary action which the college authorities deem appropriate in the circumstances.





