Can I Purchase Case Documents Online?

Documents are now available to purchase online. The cost is \$0.50 per page pursuant to NRS 19.013. An additional 3% convenience fee is added for online document purchase pursuant to NRS 1.113.

Access to view electronic documents is still available at no cost at the Clerk's Office and anyone can order copies of documents pursuant to NRS 19.013. Certified and Exemplified copies are not available online.

Sealed cases and certain information that is exempt from disclosure will NOT appear on the Portal. Please visit the court where the case was initiated for more information.

Our case management system contains both TIFF and PDF file types. You will need a specialized program on your computer to view each of these file types. More information can be found by searching the web for "TIFF reader" or "PDF reader".
