



Sept. 14 Service Change



Major bus service changes are coming to Community Transit!

With the start of Sound Transit's Link 1 Line service to Lynnwood on Aug. 30, Community Transit is expanding local and express bus service within Snohomish County on Sept. 14. Fast and frequent service makes local travel easier for all and connects riders to light rail at Lynnwood, Mountlake Terrace, and Shoreline.

Here is what you can expect on Sept. 14:

- Commuter routes to Northgate and Seattle will be eliminated and replaced with new express and local routes that connect to light rail.
- More bus service, running more often, including extending the Swift Blue Line to the Shoreline North/185th light rail station.
- New bus schedules on most routes for more reliable service. All riders should check their schedules for changes.
- Simplified bus fares start Sept. 1 — \$2.50 for adults, \$1.25 discounted fares for those who qualify, and kids ride free.

Route 105

Route 105 is being eliminated and replaced with Routes 103, 106, 120, and Swift Green Line

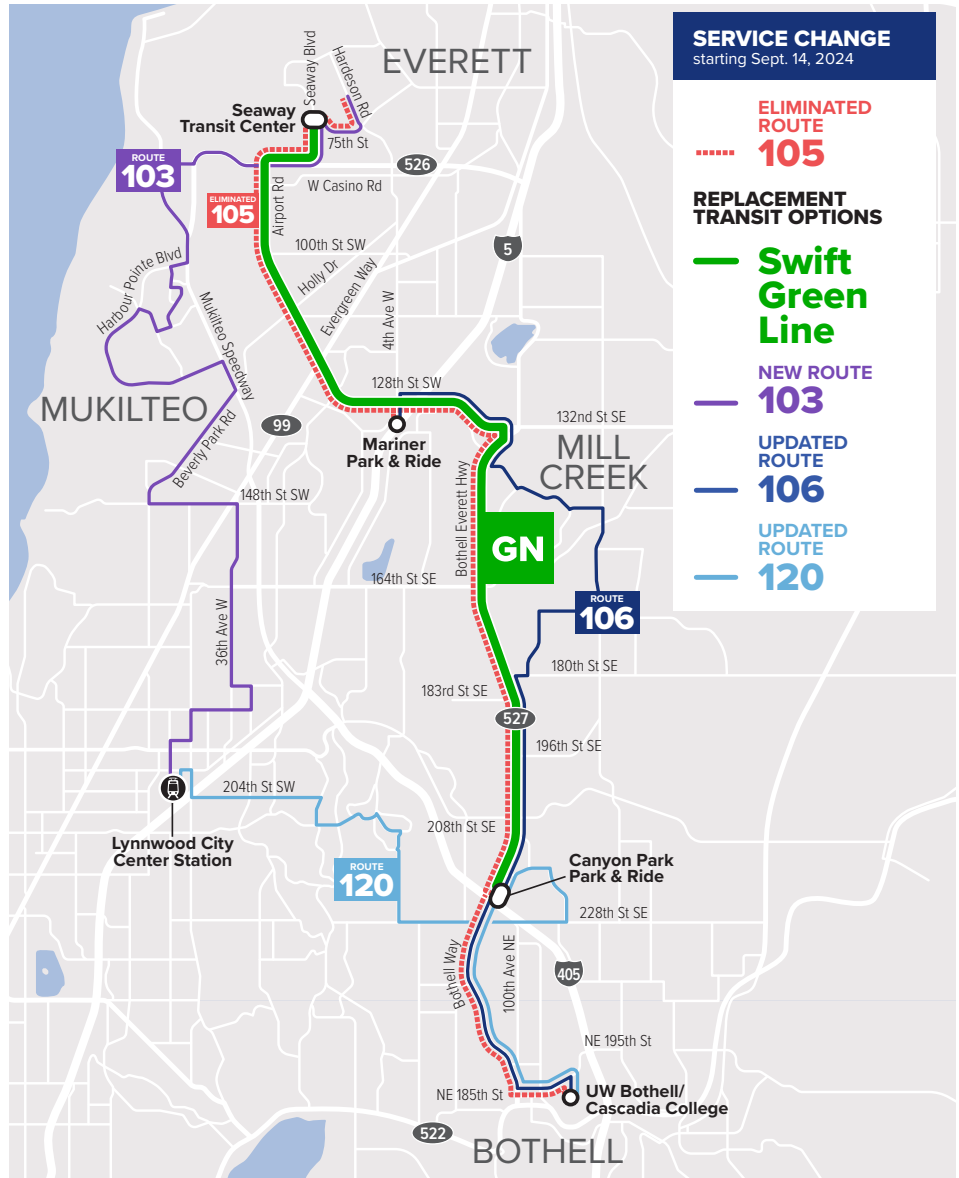
What's changing?

Route 105 is being eliminated and replaced with several new routes starting Sept. 14.

The Swift Green Line (Seaway–Canyon Park) mirrors Route 105's service from Seaway to Canyon Park Park & Ride.

Service from Canyon Park to UW Bothell/Cascadia College will be provided by Routes 106 (Mariner–Bothell) and 120 (Bothell–Lynnwood).

In Everett, service will also be provided by Route 103 (Seaway/Hardeson Road–Lynnwood).

Routes 107 and 113

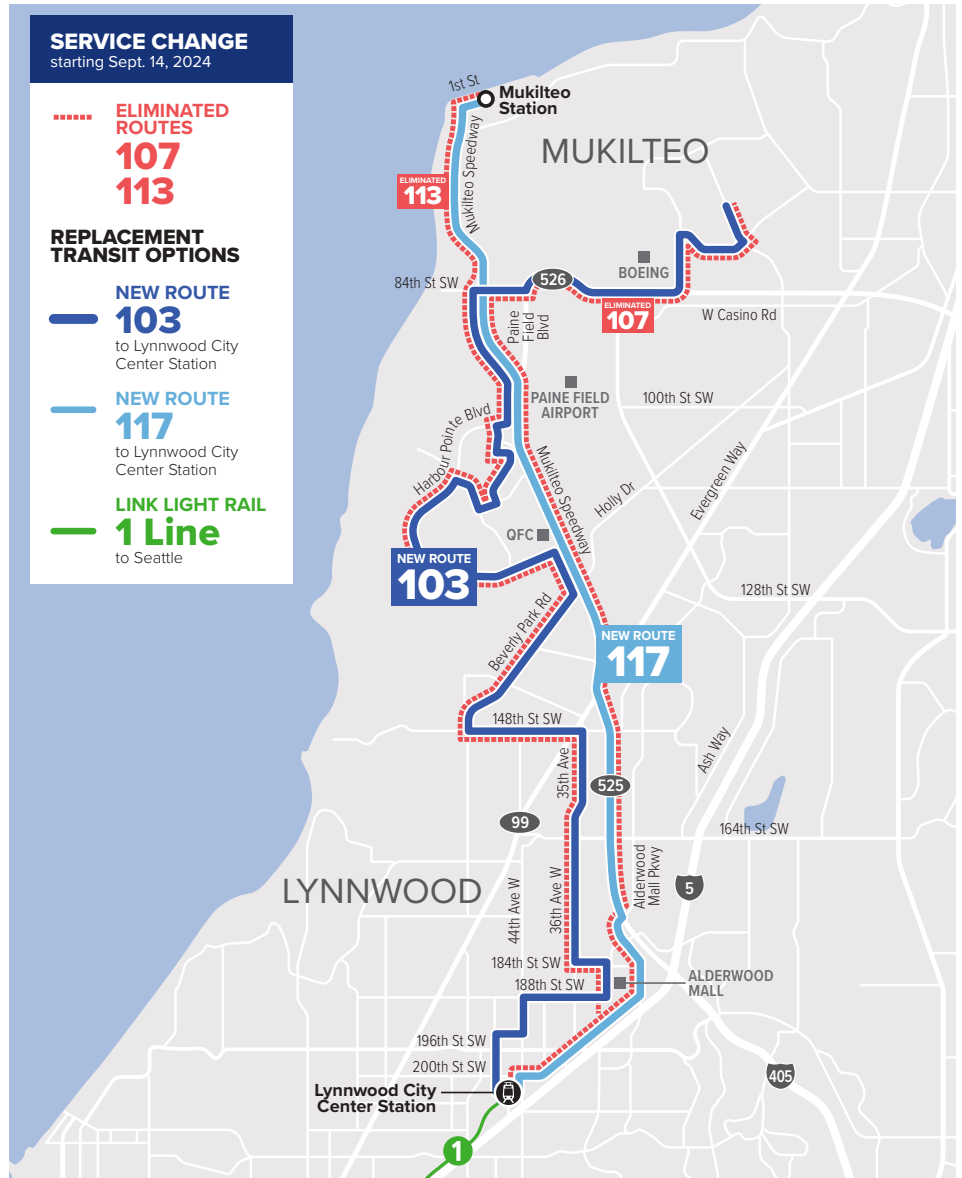
Routes 107 and 113 are being eliminated and replaced with Routes 103 and 117

What's changing?

Routes 107 and 113 are being eliminated and replaced with Routes 103 (Seaway/Hardeson Road–Lynnwood) and 117 (Mukilteo–Lynnwood) starting Sept. 14.

Route 113 riders will use new Route 117 between Mukilteo Station and SR 526 as well as Alderwood Mall to Lynnwood City Center Station. For the rest of the route, the new Route 103 mirrors Route 113.

Route 107 riders will use new Route 103 between Hardeson and the Mukilteo Speedway. For the rest of the route, new Route 117 mirrors Route 107.

Route 103 provides service between Mukilteo and Lynnwood City Center Station, via Boeing and Harbour Pointe.



Route 117 provides service from Mukilteo Station to Lynnwood City Center Station along Mukilteo Speedway.

Routes 227 and 247

Routes 227 and 247 are being eliminated and replaced with Routes 905 and 907

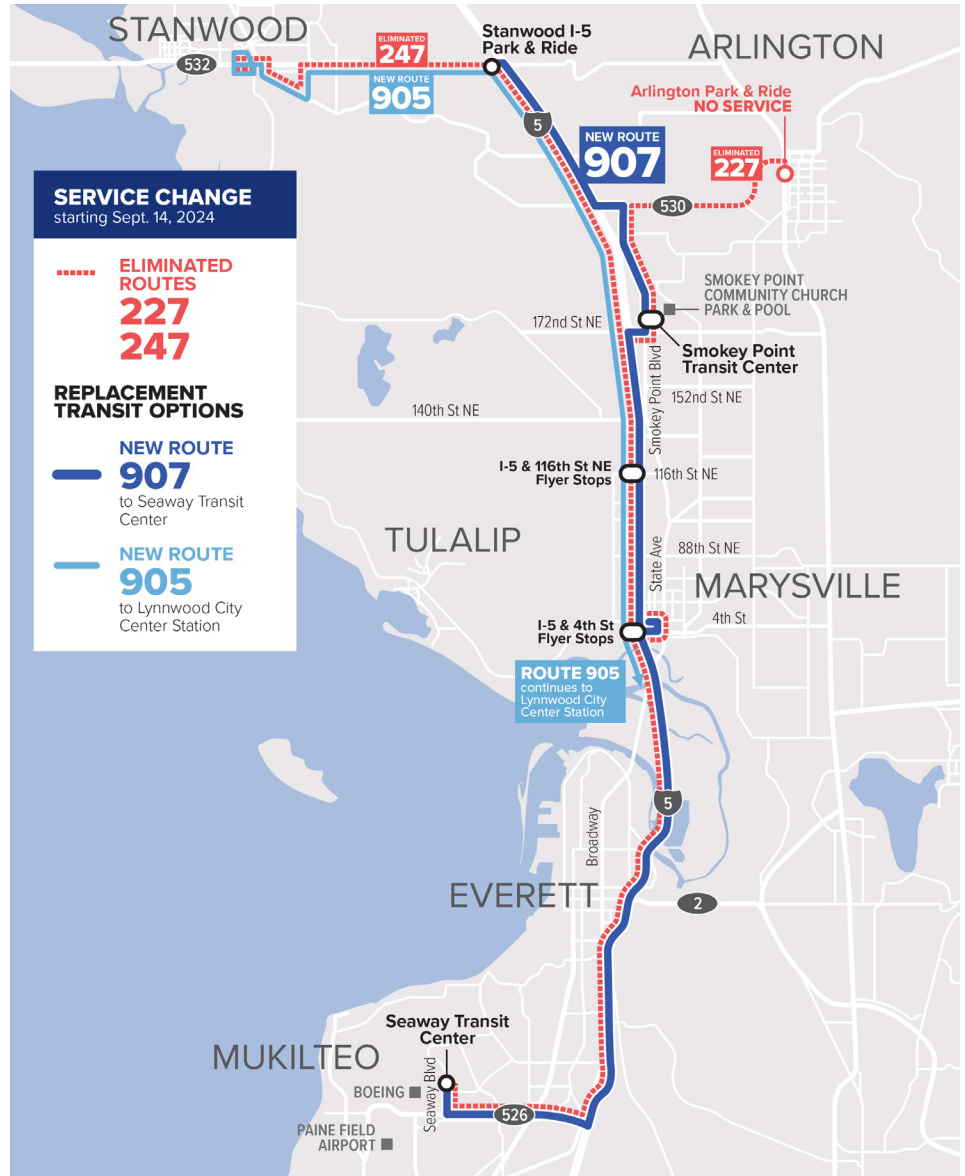
What's changing?

Routes 227 and 247 are being eliminated and replaced with new express Routes 905 (Stanwood–Lynnwood) and 907 (Stanwood–Seaway) on Sept. 14.

Service from downtown Stanwood is covered by new express Route 905, which continues to Lynnwood City Center Station.

Service from Stanwood I-5 Park & Ride through Smokey Point Transit Center, Marysville and to Seaway Transit Center will be provided by Route 907.

Riders will use the Smokey Point Community Church Park & Pool to access Routes 905 and 907. Arlington Park & Ride will no longer have bus service.

Route 402

Route 402 is being eliminated and replaced with Link light rail 1 Line

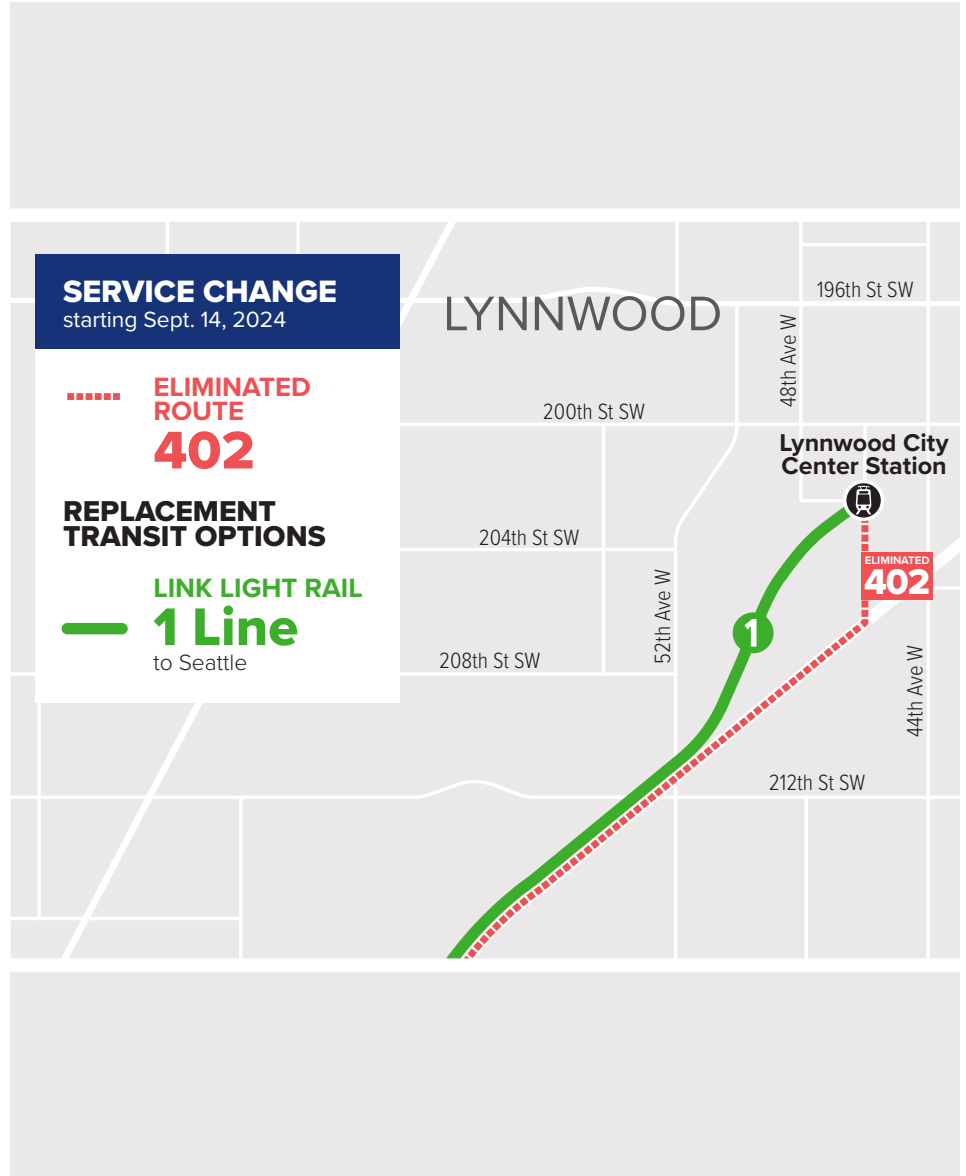
What's changing?

Route 402 into Seattle is being eliminated and will be replaced with Link light rail 1 Line on Sept. 14.

Riders will catch light rail at Lynnwood City Center Station (formerly Lynnwood Transit Center).

Riders can also use the new ST Express Route 515 (Lynnwood City Center–Downtown Seattle).

Route 405

Route 405 is being eliminated and replaced with Routes 102, 119, Swift Blue Line, and Link light rail 1 Line

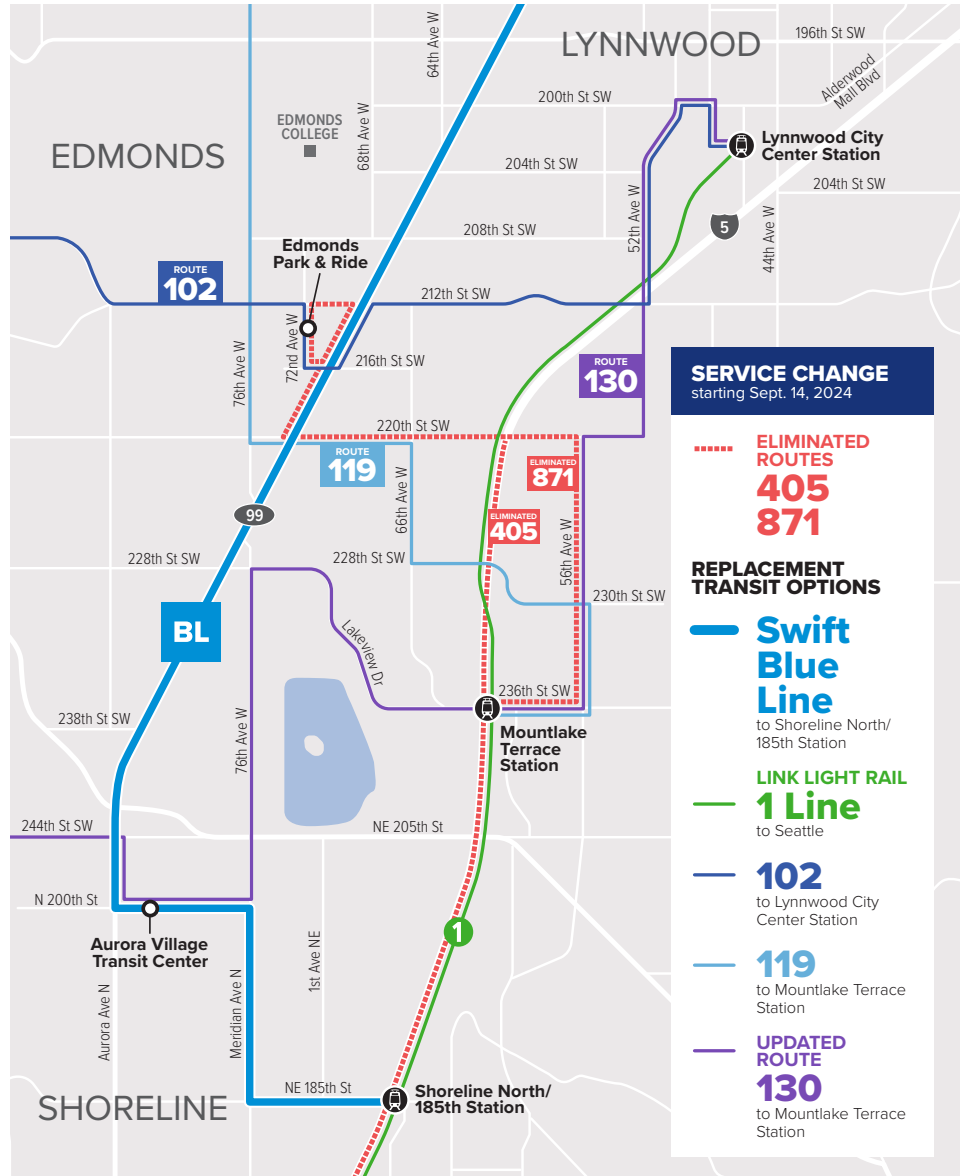
What's changing?

Route 405 is being eliminated and replaced with several new routes starting Sept. 14.

Route 102 (Edmonds–Lynnwood) provides service from Edmonds Park & Ride to Lynnwood City Center Station to connect with light rail.

Route 119 (Ash Way–Mountlake Terrace) provides service along 220th St SW previously served by Route 405 and on to Mountlake Terrace Station to connect with light rail.

Swift Blue Line (Everett–Aurora Village) provides service along Highway 99 and connects with light rail at the Shoreline North/185th Station.

Route 119 provides service every 30 minutes during peak times into Mountlake Terrace and its light rail station.

Routes 410 and 860

Routes 410 and 860 are being eliminated and replaced with Routes 201/202, 901, and Link light rail 1 Line

What's changing?

Routes 410 and 860 are being eliminated and replaced with several transit options to connect to Link light rail 1 Line starting Sept. 14.

Route 901 (Silver Fir–Lynnwood) will provide service from McCollum Park Park & Ride to Lynnwood City Center Station to connect with light rail.

Routes 201 and 202 (Smokey Point–Lynnwood) will provide service from Mariner Park & Ride and Ash Way Park & Ride to the Lynnwood City Center Station to connect with light rail.

Service into Seattle will be provided by Link light rail 1 Line.

Route 412

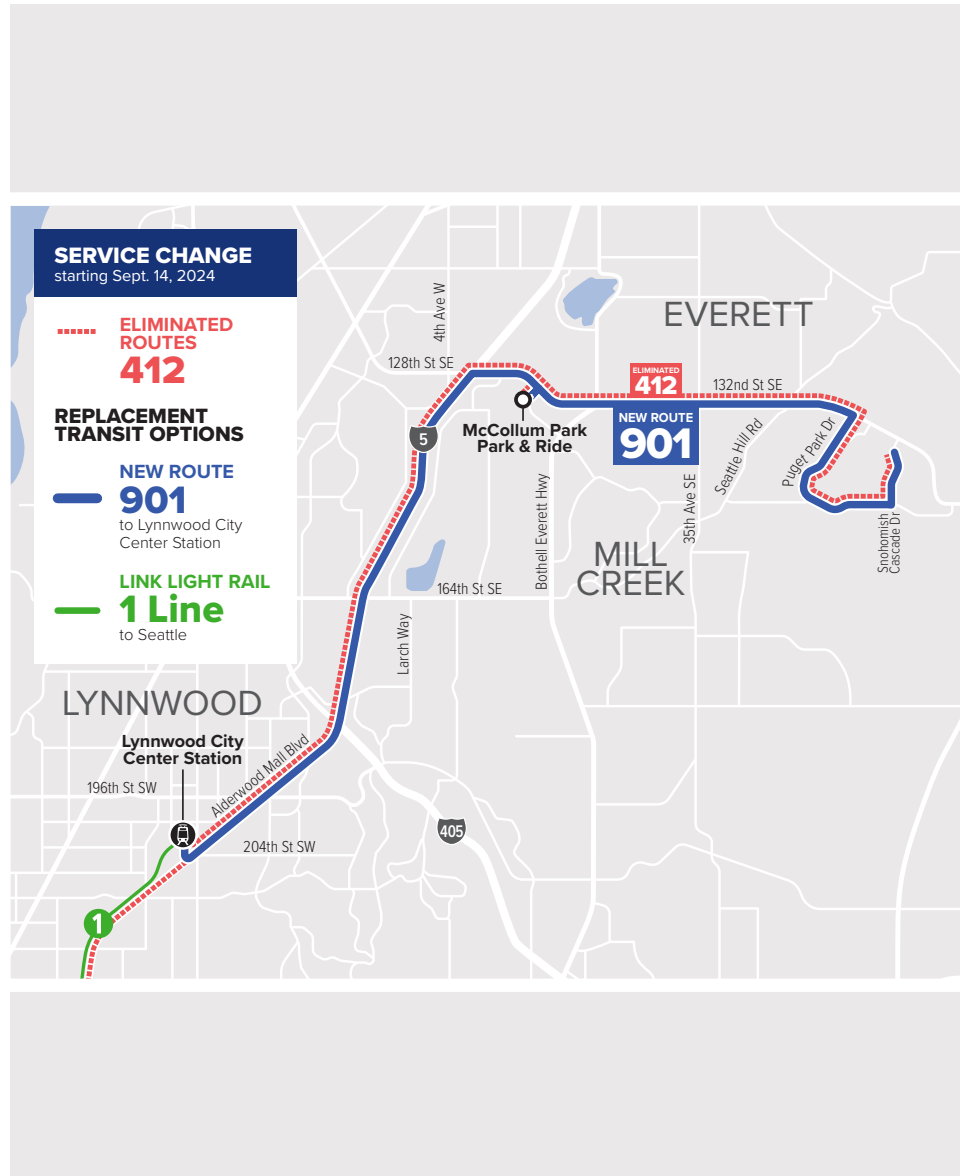
Route 412 is being eliminated and replaced with Route 901 and the Link light rail 1 Line

What's changing?

Route 412 is being eliminated and replaced with a new express route and Link light rail starting Sept. 14.

Route 901 (Silver Firs–Lynnwood) operates along the exact path of Route 412 from Silver Firs to Lynnwood City Center Station.

From Lynnwood City Center Station, riders transfer to Link light rail 1 Line to continue to Seattle.

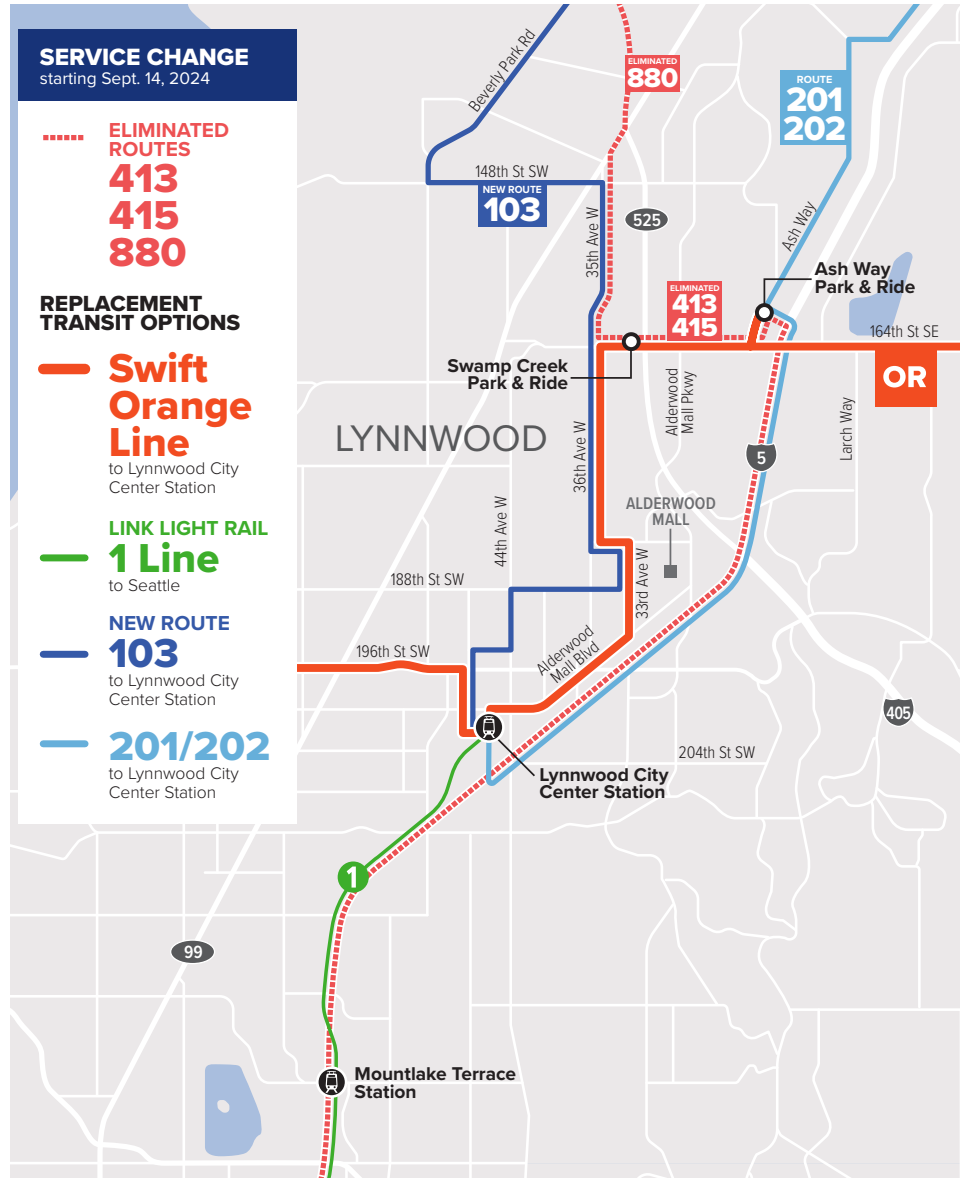
What's changing?

Routes 413, 415, and 880 are being eliminated and replaced with several options to connect to Link light rail 1 Line starting Sept. 14.

Swift Orange Line (Edmonds College–McCollum Park) will connect to Lynnwood City Center Station from Ash Way Park & Ride and Swamp Creek Park & Ride.

Route 103 (Seaway/Hardeson Road–Lynnwood) will serve 35th Ave W, connecting to Lynnwood City Center Station.

Service to Mountlake Terrace Station and onto Seattle will be covered by Link Light Rail 1 Line.

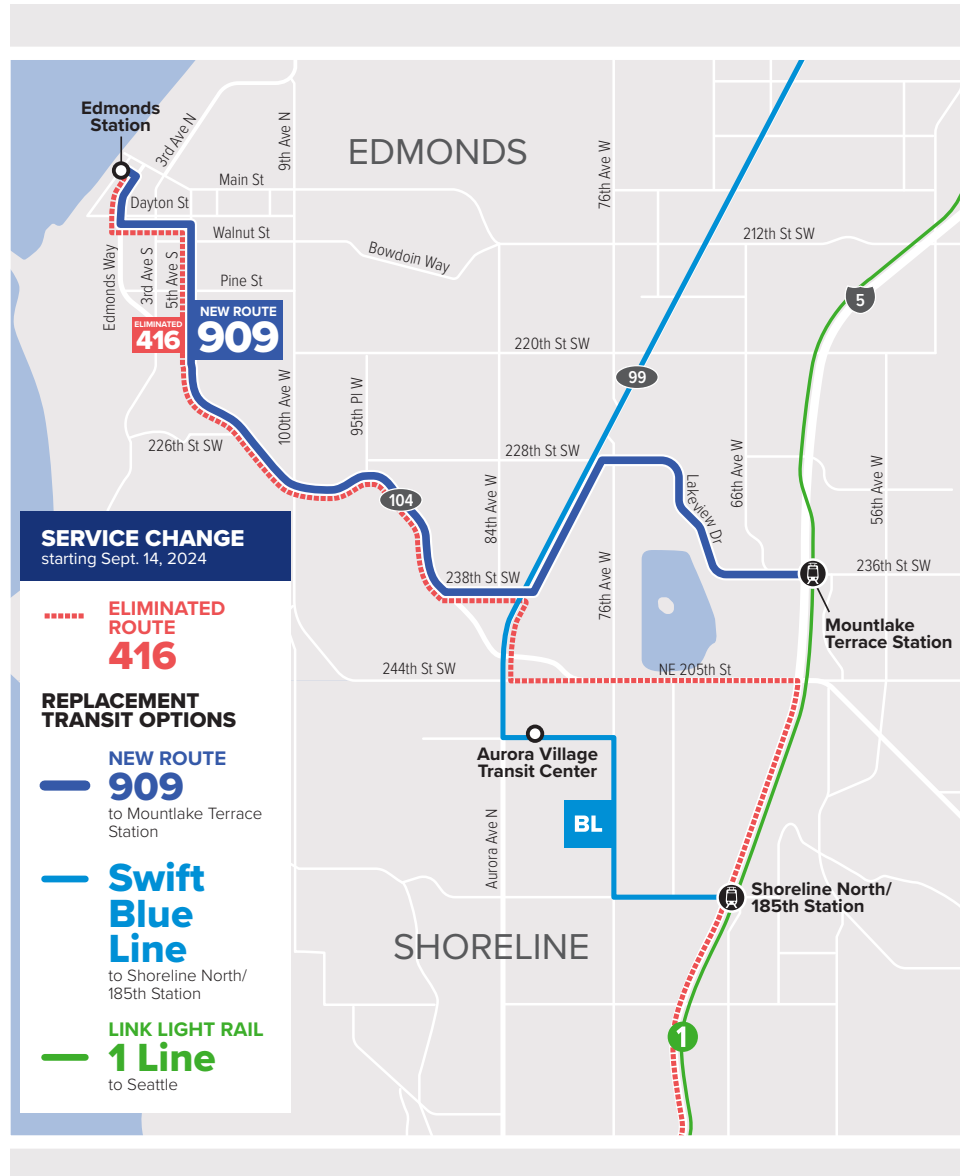

Route 909 (Edmonds–Mountlake Terrace) will provide service between Edmonds Station and Mountlake Terrace Station.

For service along Highway 99 between 238th St SW and 244 St SW in Mountlake Terrace, riders can use the Swift Blue Line (Everett–Aurora Village) to connect to light rail at Shoreline North/185th Station.

Service into Seattle will be provided by Link light rail 1 Line.

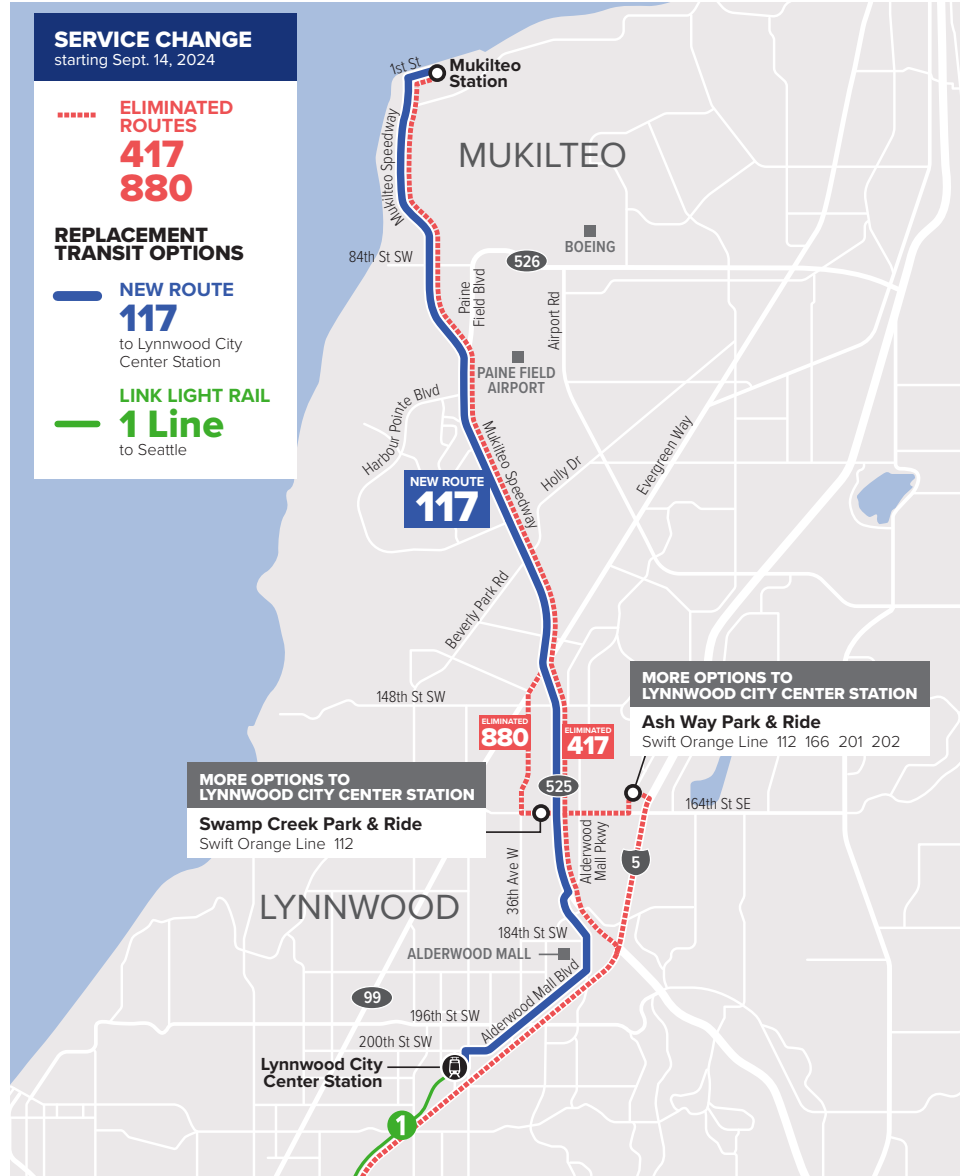

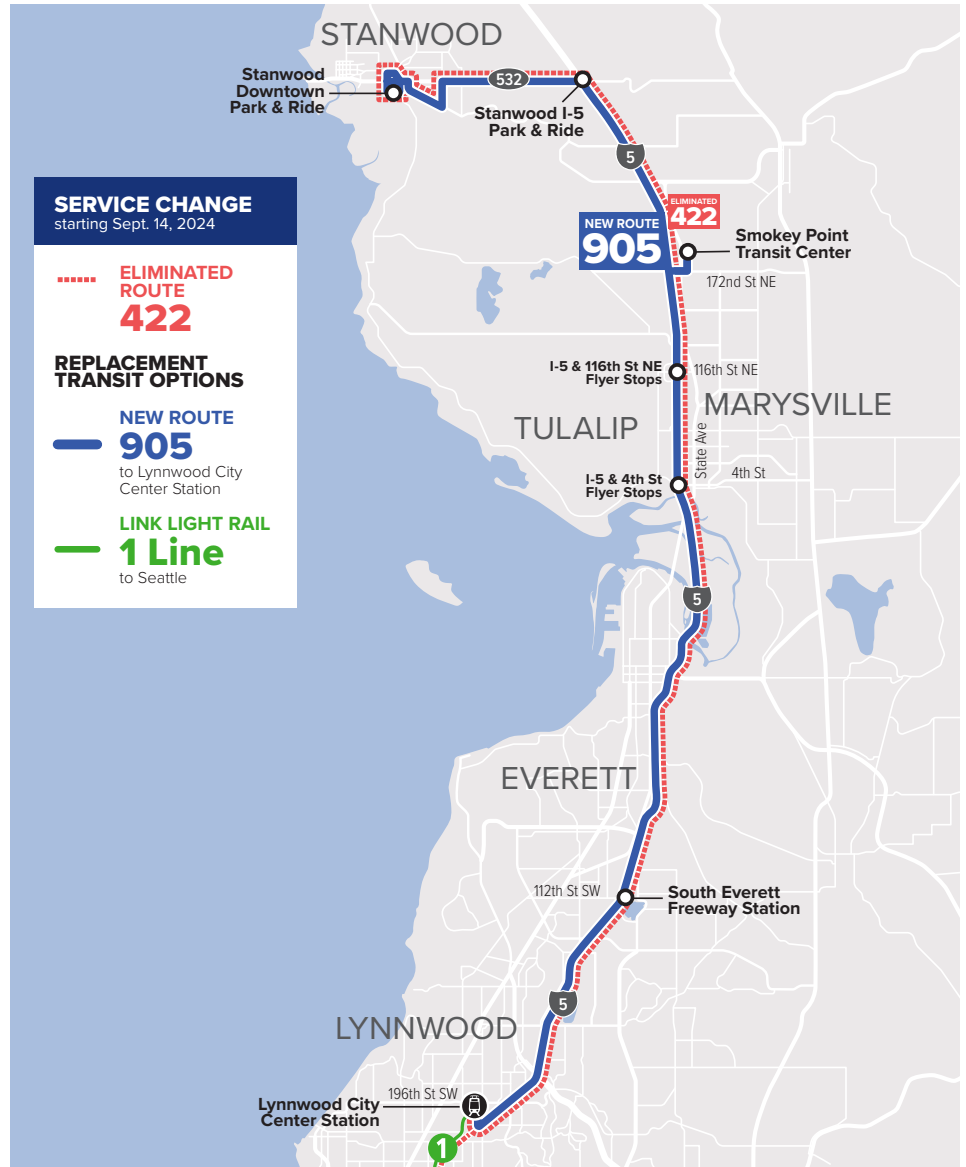

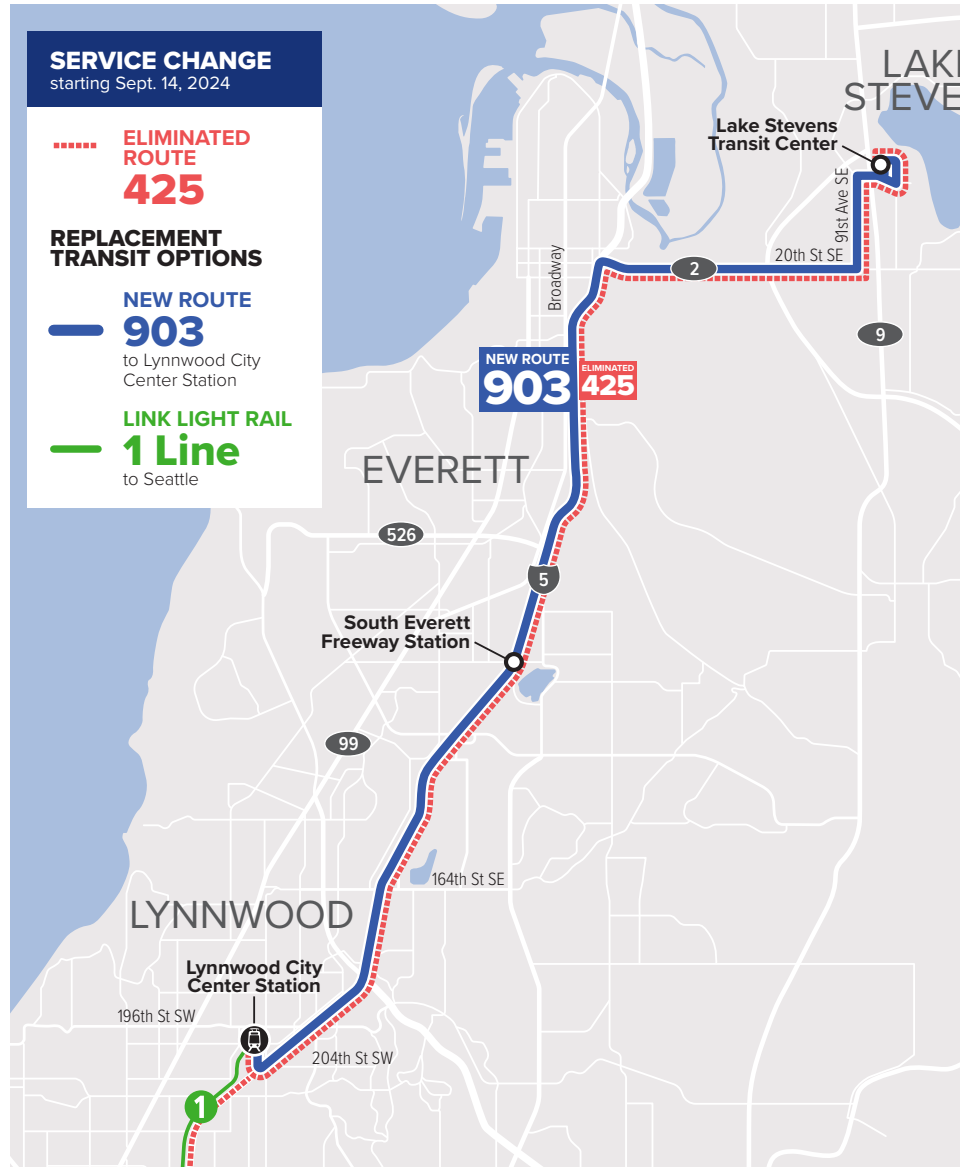

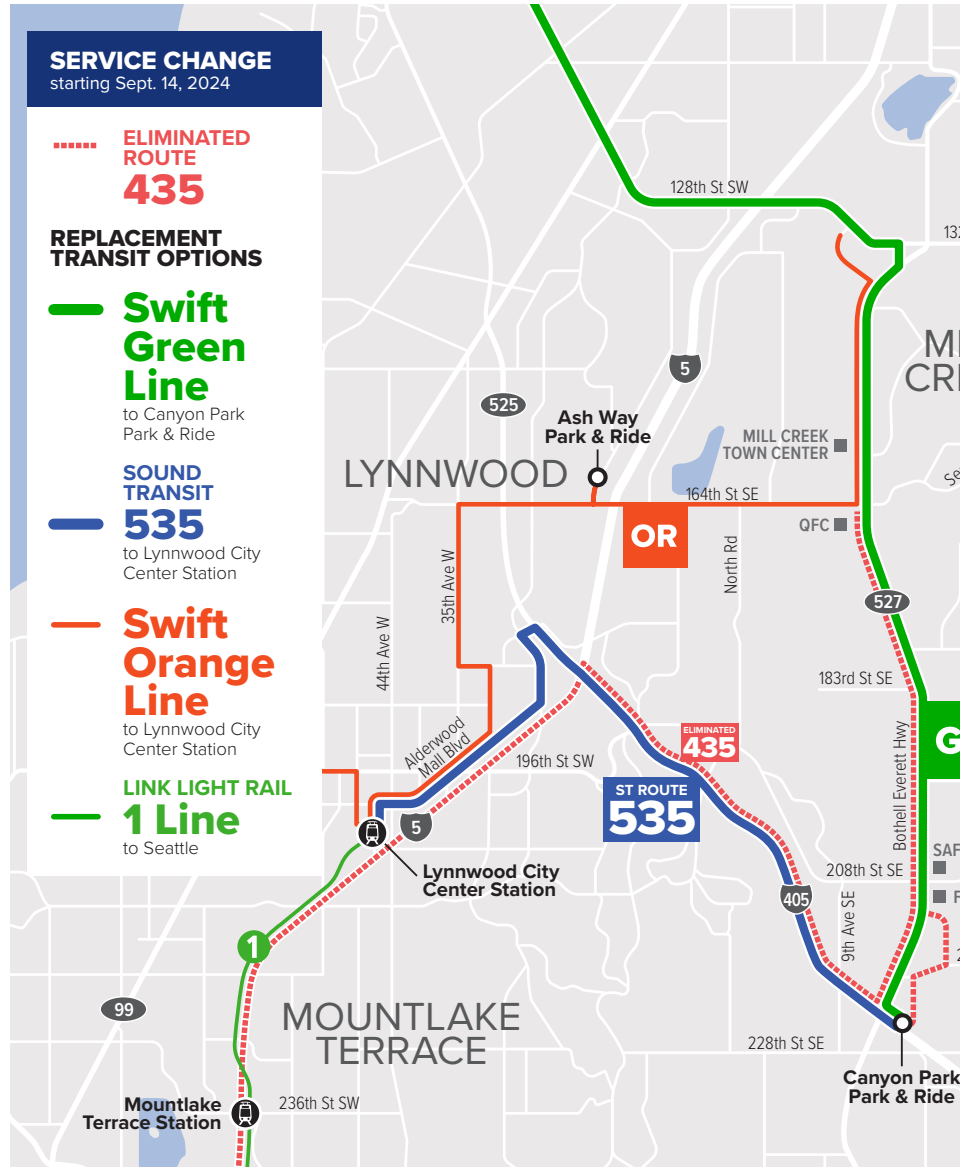

Service along the Bothell Everett Highway will be covered by the Swift Green Line (Seaway–Canyon Park) and Route 106 (Mariner Park & Ride–Bothell).

Service from Canyon Park Park & Ride and Lynnwood City Center Station will be covered by Sound Transit Route 535 (Lynnwood–Bellevue).

The route will run regularly in both directions, providing direct service from Mukilteo to the Lynnwood City Center Station with an easy connection to Paine Field via Swift Green Line.

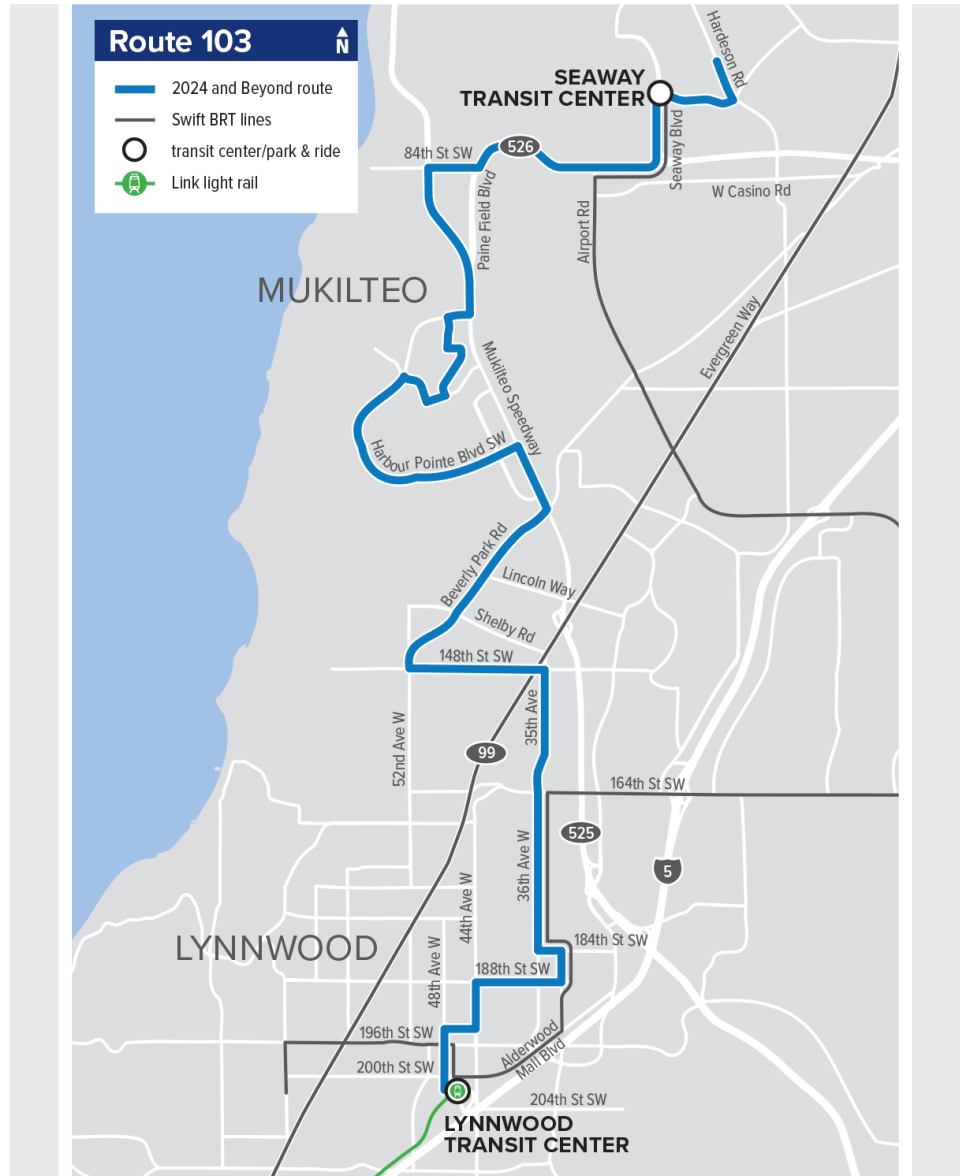

Route 121 serves UW Bothell/Cascadia College during busy morning and afternoon travel times. During the mid-day and evening, it runs between Ash Way and Canyon Park only. It will serve new areas of Bothell along North Rd and Filbert Rd, including Lynnwood High School. The route connects to Swift Green and Swift Orange lines.

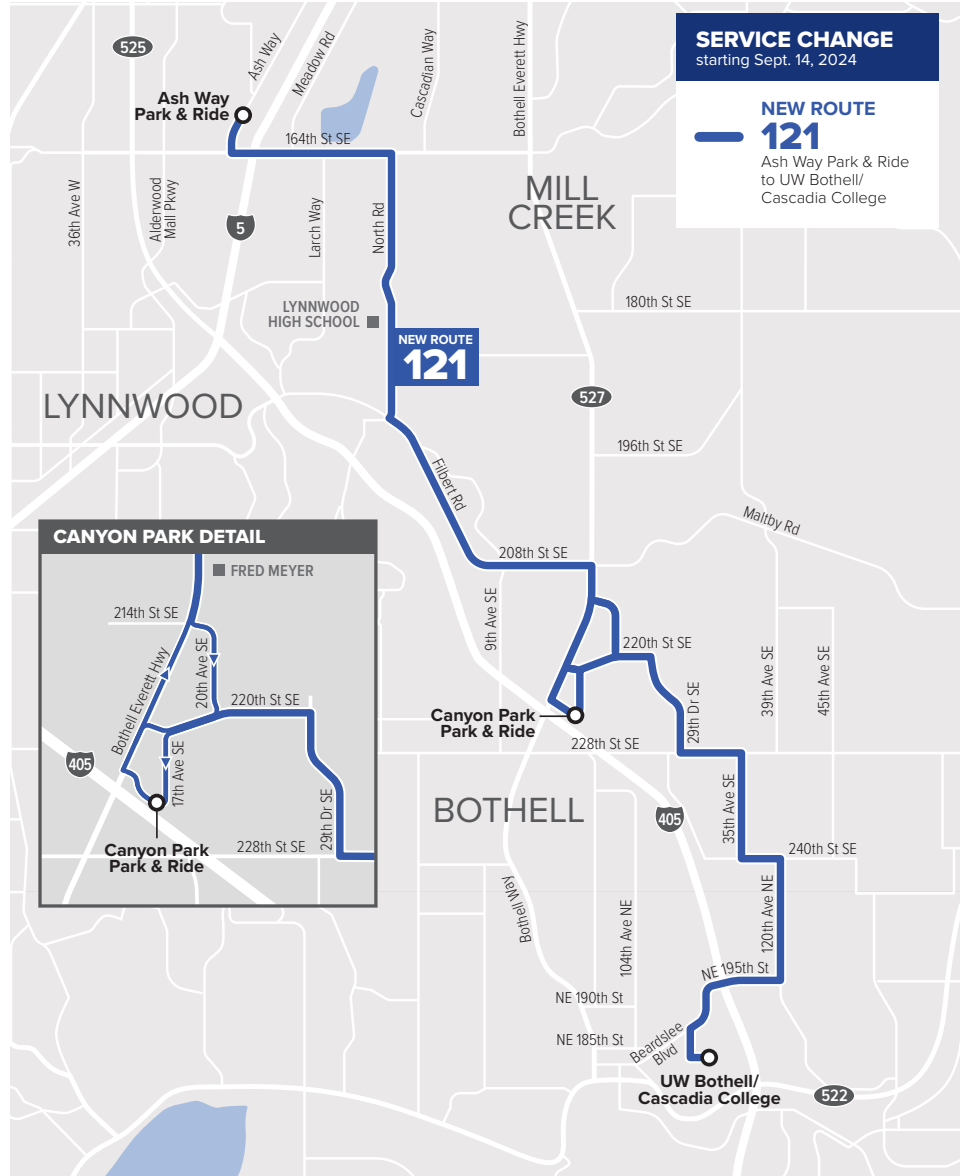

During AM hours the route will run westbound, while at PM hours it will run eastbound. It also connects to the Swift Green and Swift Orange lines.

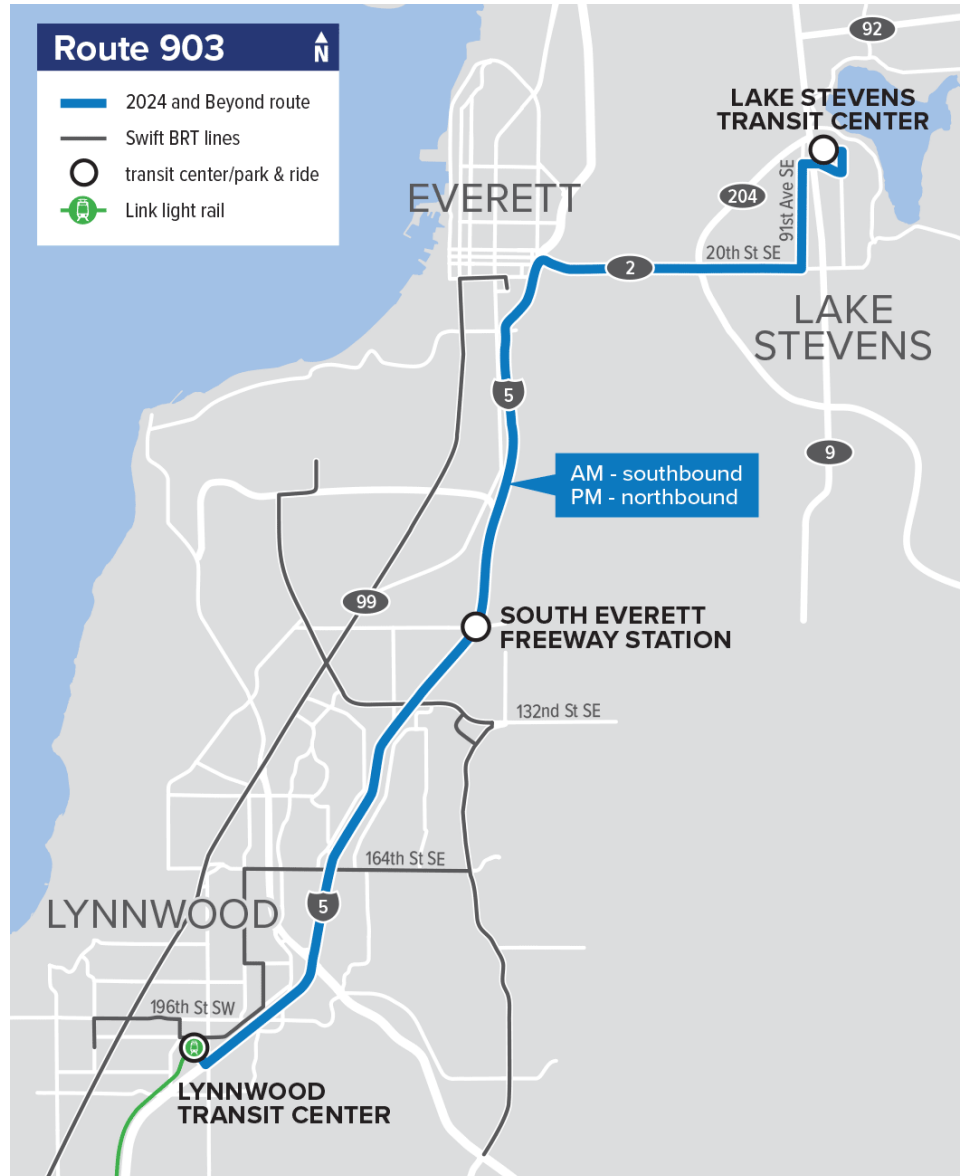
