Resolved, That the bill from the House of Representatives (H.R. 1195) entitled “An Act to amend the Safe, Accountable, Flexible, Efficient Transportation Equity Act: A Legacy for Users to make technical corrections, and for other purposes.”, do pass with the following

20 **TITLE IV—MISCELLANEOUS**
21 **PROVISIONS**

22 **SEC. 401. CONVEYANCE OF GSA FLEET MANAGEMENT CEN-**
23 **TER TO ALASKA RAILROAD CORPORATION.**

24 *(a) IN GENERAL.—Subject to the requirements of this*
25 *section, the Administrator of General Services shall convey,*

1 *not later than 2 years after the date of enactment of this*
2 *Act, by quitclaim deed, to the Alaska Railroad Corporation,*
3 *an entity of the State of Alaska (in this section referred*
4 *to as the “Corporation”), all right, title, and interest of the*
5 *United States in and to the parcel of real property described*
6 *in subsection (b), known as the GSA Fleet Management*
7 *Center.*

8 *(b) GSA FLEET MANAGEMENT CENTER.—The parcel*
9 *to be conveyed under subsection (a) is the parcel located*
10 *at the intersection of 2nd Avenue and Christensen Avenue*
11 *in Anchorage, Alaska, consisting of approximately 78,000*
12 *square feet of land and the improvements thereon.*

13 *(c) CONSIDERATION.—*

14 *(1) IN GENERAL.—As consideration for the par-*
15 *cel to be conveyed under subsection (a), the Adminis-*
16 *trator shall require the Corporation to—*

17 *(A) convey replacement property in accord-*
18 *ance with paragraph (2); or*

19 *(B) pay the purchase price for the parcel in*
20 *accordance with paragraph (3).*

21 *(2) REPLACEMENT PROPERTY.—If the Adminis-*
22 *trator requires the Corporation to provide consider-*
23 *ation under paragraph (1)(A), the Corporation*
24 *shall—*

1 (A) convey, and pay the cost of conveying,
2 to the United States, acting by and through the
3 Administrator, fee simple title to real property,
4 including a building, that the Administrator de-
5 termines to be suitable as a replacement facility
6 for the parcel to be conveyed under subsection
7 (a); and

8 (B) provide such other consideration as the
9 Administrator and the Corporation may agree,
10 including payment of the costs of relocating the
11 occupants vacating the parcel to be conveyed
12 under subsection (a).

13 (3) *PURCHASE PRICE.*—If the Administrator re-
14 quires the Corporation to provide consideration under
15 paragraph (1)(B), the Corporation shall pay to the
16 Administrator the fair market value of the parcel to
17 be conveyed under subsection (a) based on its highest
18 and best use as determined by an independent ap-
19 praisal commissioned by the Administrator and paid
20 for by the Corporation.

21 (d) *APPRAISAL.*—In the case of an appraisal under
22 subsection (c)(3)—

23 (1) the appraisal shall be performed by an ap-
24 praiser mutually acceptable to the Administrator and
25 the Corporation; and

1 (2) *the assumptions, scope of work, and other*
2 *terms and conditions related to the appraisal assign-*
3 *ment shall be mutually acceptable to the Adminis-*
4 *trator and the Corporation.*

5 (e) *PROCEEDS.*—

6 (1) *DEPOSIT.*—*Any proceeds received under sub-*
7 *section (c) shall be paid into the Federal Buildings*
8 *Fund established under section 592 of title 40, United*
9 *States Code.*

10 (2) *EXPENDITURE.*—*Funds paid into the Fed-*
11 *eral Buildings Fund under paragraph (1) shall be*
12 *available to the Administrator, in amounts specified*
13 *in appropriations Acts, for expenditure for any law-*
14 *ful purpose consistent with existing authorities grant-*
15 *ed to the Administrator; except that the Adminis-*
16 *trator shall provide to the Committee on Transpor-*
17 *tation and Infrastructure of the House of Representa-*
18 *tives and the Committee on Environment and Public*
19 *Works of the Senate 30 days advance written notice*
20 *of any expenditure of the proceeds.*

21 (f) *ADDITIONAL TERMS AND CONDITIONS.*—*The Ad-*
22 *ministrator may require such additional terms and condi-*
23 *tions to the conveyance under subsection (a) as the Admin-*
24 *istrator considers appropriate to protect the interests of the*
25 *United States.*

1 (g) *DESCRIPTION OF PROPERTY AND SURVEY.*—The
2 *exact acreage and legal description of the parcels to be con-*
3 *veyed under subsections (a) and (c)(2) shall be determined*
4 *by surveys satisfactory to the Administrator and the Cor-*
5 *poration.*

6 **SEC. 402. CONVEYANCE OF RETAINED INTEREST IN ST. JO-**
7 **SEPH MEMORIAL HALL.**

8 (a) *IN GENERAL.*—Subject to the terms and conditions
9 of subsection (c), the Administrator of General Services
10 shall convey to the city of St. Joseph, Michigan, by quit-
11 claim deed, any interest retained by the United States in
12 St. Joseph Memorial Hall.

13 (b) *ST. JOSEPH MEMORIAL HALL DEFINED.*—In this
14 section, the term “St. Joseph Memorial Hall” means the
15 property subject to a conveyance from the Secretary of Com-
16 merce to the city of St. Joseph, Michigan, by quitclaim deed
17 dated May 9, 1936, recorded in Liber 310, at page 404,
18 in the Register of Deeds for Berrien County, Michigan.

19 (c) *TERMS AND CONDITIONS.*—The conveyance under
20 subsection (a) shall be subject to the following terms and
21 conditions:

22 (1) *CONSIDERATION.*—As consideration for the
23 conveyance under subsection (a), the city of St. Jo-
24 seph, Michigan, shall pay \$10,000 to the United
25 States.

1 (2) *ADDITIONAL TERMS AND CONDITIONS.*—*The*
2 *Administrator may require such additional terms and*
3 *conditions for the conveyance under subsection (a) as*
4 *the Administrator considers appropriate to protect the*
5 *interests of the United States.*

6 ***TITLE V—OTHER PROVISIONS***

7 ***SEC. 501. DE SOTO COUNTY, MISSISSIPPI.***

8 *Section 219(f)(30) of the Water Resources Development*
9 *Act of 1992 (106 Stat. 4835; 110 Stat. 3757; 113 Stat. 334;*
10 *114 Stat. 2763A–220; 119 Stat. 282; 119 Stat. 2257) is*
11 *amended by striking “\$55,000,000” and inserting*
12 *“\$75,000,000”.*

13 ***SEC. 502. DEPARTMENT OF JUSTICE REVIEW.***

14 *Consistent with applicable standards and procedures,*
15 *the Department of Justice shall review allegations of impro-*
16 *priety regarding item 462 in section 1934(c) of Public Law*
17 *109–59 to ascertain if a violation of Federal criminal law*
18 *has occurred.*
