Delegations will find attached the European Semester roadmap, as prepared by the Presidency in consultation with the incoming Presidency.

---

The Presidency has prepared this roadmap to outline the key steps of the 2024 European Semester cycle.

The objective of the roadmap is to ensure that all relevant Council configurations, and their preparatory bodies, work in a coordinated and consistent manner towards a thorough preparation of the European Council discussions on the European Semester and to enable Coreper and the General Affairs Council to oversee the process.

## **FIRST PHASE**

### **Run-up to the March European Council**

#### **9 October 2023: Employment, Social Policy, Health and Consumer Affairs Council**

- Key employment challenges: Key messages from the Employment Committee based on the Annual Employment Performance Report and the Employment Performance Monitor - *endorsement*

- Council Decision on guidelines for the employment policies of the Member States - *adoption*
