Wages and Conditions in the Electrical Contracting Industry

On 1st July 1966 the Government referred the question of wages and conditions in the electrical contracting industry to the National Board for Prices and Incomes for examination under the terms

of the Royal Warrant constituting the Board as a Royal Commission.

Since that date the Board has been reconstituted under section 1 of the Prices and Incomes Act 1966, and to enable the Board to make its report on this reference in accordance with the Act, the First Secretary of State and the Minister of Labour formally referred the question to the Board under section 2 of the Act on 2nd November 1966.

The Board has now made its report and in accordance with section 5(1) of the Prices and Incomes Act 1966 the First Secretary of State and the Minister of Labour hereby give notice that the report was first published as Command Paper Number 3172 on 22nd December, 1966.
