REGULATIONS TO BE OBSERVED AT THE KING'S LEVEES, AT ST. JAMES'S-PALACE.

The Noblemen and Gentlemen who propose to attend His Majesty's Levees at St. James's-Palace, are requested to bring with them two cards with their names thereon written, one to be left with the King's Page in attendance in the Presence-Chamber, and the other to be delivered to the Lord in Waiting, who will announce the name to His Majesty. And those Gentlemen who are to be presented are hereby informed, it is absolutely necessary that their names, with the name of the Gentleman who is to present them (not the Lord in Waiting), should be sent in to the Lord Chamberlain's-Office, BEFORE twelve o'clock on the Monday previous to each Levee, in order that they may be submitted for the King's approbation; it being His Majesty's command, that no presentation shall hereafter be made at the Levee, but in conformity with the above regulations; and further, that no person shall be admitted, on any pretence whatever, who has not been so présented.

It is particularly requested, that Gentlemen who are to be presented at the Levees will have their names distinctly written upon the eard to be delivered to December 21—St. Matthew October 18—St. Luke. October 28—St. Simon and November 30—St. Andrew. December 21—St. Thomas,

St. James's-Palace, April 22, 1831.

THIS day His Majesty proceeded in state from St. James's-Palace to the House of Peers, where he arrived about three o'clock; and, having alighted from the state coach, was received at the portico by the Great Officers of State and others, and proceeded to the robing-room in the customary manner.

His Majesty was there robed, and the procession moved into the House in the usual order.

His Majesty being seated upon the Throne, the Great Officers of State and others standing on the right and left, Sir Thomas Tyrwhitt, Knt. Gentleman Usher of the Black Rod, was sent with a message from His Majesty to the House of Commons, commanding their attendance in the House of Peers. The Commons being come thither accordingly, His Majesty was pleased to deliver the following most gracious Speech to both Houses of Parliament:

My Lords, and Gentlemen,

I HAVE come to meet you for the purpose of proroguing this Parliament, with a view to its immediate dissolution.

I have been induced to resort to this measure for the purpose of ascertaining the sense of My People, in the way in which it can be most constitutionally and authentically expressed, on the expediency of making such changes in the Representation as circumstances may appear to require, and which, founded upon the acknowledged principles of the Constitution, may tend at once to uphold the just rights and prerogatives of the Crown, and to give security to the liberties of the People.

Gentlemen of the House of Commons,

I thank you for the provision you have made for the maintenance of the honour and dignity of the Crown, and I offer you my special acknowledgments for the arrangements you have made for the state and comfort of My Royal Consort; I have also to thank you for the supplies which you have furnished for the public service; I have observed with satisfaction your endeavours to introduce a strict economy into every branch of that service; and I trust that the early attention of a new Parliament, which I shall forthwith direct to be called, will be applied to the prosecution of that important object.

My Lords, and Gentlemen,

I am happy to inform vou, that the friendly intercourse which subsists between Myself and Foreign Powers, affords the best hopes of the continuance of Peace, to the preservation of which My most anxious endeavours will be constantly directed.

My Lords, and Gentlemen,

In resolving to recur to the sense of My People, in the present circumstances of the Country, I have been influenced only by a paternal anxiety for the contentment and happiness of My Subjects, to promote which I rely with confidence on your continued and zealous assistance.

Then the Lord Chancellor, by His Majesty's command, prorogued the Parliament accordingly.

#### A PROCLAMATION,

For dissolving the present Parliament, and declaring the calling of another.

WILLIAM, R.

HEREAS We have thought fit, by and with the advice of Our Privy Council, to dissolve this present Parliament, which stands prorogued to Tuesday the tenth day of May next: We do for that end publish this Our Royal Proclamation, and do hereby dissolve the said Parliament accordingly; and the Lords Spiritual and Temporal, and the Knights, Citizens, and Burgesses, and the Commissioners for shires and burghs, of the House of Commons are discharged from their meeting and attendance on the said Tuesday the tenth day of May next: and We, being desirous and resolved, as soon as may be, to meet Our people, and to have their advice in Parliament, do hereby make known to all Our loving subjects Our Royal will and pleasure to call a new Parliament: and do hereby further declare, that, with the advice of Our Privy Council, We have given order to

Our Chancellor of that part of Our United Kingdom called Great Britain, and Our Chancellor of Ireland, that they do respectively, upon notice thereof, forthwith issue out writs in due form, and according to law, for calling a new Parliament: and We do hereby also, by this Our Royal Proclamation under Our Great Seal of Our United Kingdom, require writs forthwith to be issued accordingly by Our said Chancellors respectively, for causing the Lords Spiritual and Temporal and Commons, who are to serve in the said Parliament, to be duly returned to, and give their attendance in, Our said Parliament; which writs are to be returnable on Tuesday the fourteenth day of June next.

#### A PROCLAMATION,

In order to the electing and summoning the Sixteen Peers of Scotland.

WILLIAM, R.

7 HEREAS We have in Our Council thought fit to declare Our pleasure, for summoning and holding a Parliament of Our United Kingdom of Great Britain and Ireland, on Tuesday the fourteenth day of June next ensuing the date hereof; in order, therefore, to the electing and summoning the Sixteen Peers of Scotland, who are to sit in the House of Peers in the said Parliament: We do, by the advice of Our Privy Council, issue forth this Our Royal Proclamation, strictly charging and commanding all the Peers of Scotland to assemble and meet at Holyrood-House, in Edinburgh, on Friday the third day of June next ensuing, between the hours of twelve and two in the afternoon, to nominate and choose the sixteen Peers, to sit and vote in the House of Peers in the said ensuing Parliament, by open election and plurality of voices of the Peers that shall be then present, and of the proxies of such as shall be absent (such proxies being Peers, and producing a mandate in writing, duly signed before witnesses, and both the constituent and proxy being qualified according to law), and the Lord Clerk Register, or such two of the Principal Clerks of the Session as shall be appointed by him to officiate in his name, are hereby respectively required to attend such meeting, and to administer then Prince Regent, in the name and on the behalf

the oaths required by law to be taken there by the said Peers, and to take their votes; and immediately after such election made and duly examined, to certify the names of the Sixteen Peers so elected, and to sign and attest the same in the presence of the said Peers the electors, and return such certificate into Our High Court of Chancery of Great Britain. And We do, by this Our Royal Proclamation, strictly command and require the Provost of Edinburgh, and all other the Magistrates of the said city, to take especial care to preserve the peace thereof, during the time of the said election, and to prevent all manner of riots, tumults, disorders, and violence whatsoever. And We strictly charge and command that this Our Royal Proclamation be duly published at the Market-Cross at Edinburgh, and in all the county towns of Scotland, twenty-five days, at least, before the time hereby appointed for the meeting of the said Peers to proceed to such election.

Witness Ourself at Westminster, this twentythird day of April one thousand eight hundred and thirty-one, and in the first year of Our reign.

#### By the KING. A PROCLAMATION.

WILLIAM, R.

THEREAS by an Act, passed in the fifty-ninth year of the reign of His late Majesty King George the Third, chapter 25th, intituled " An " Act to enable His Majesty to fix a rate and direct " the disposal of freight money for the conveyance " of specie and jewels on board His Majesty's ships " and vessels," it is enacted, that from and after the eighth day of April one thousand eight hundred and nineteen, all freight money to be paid for the conveyance on board any of the ships and vessels of His Majesty, of gold, silver, and jewels, or of any other article which may by special order be received on board, and for which freight shall be payable, shall be paid at such rate and be distributed and applied for such purposes, and divided to and amongst such persons in such proportions and after such manner as His Majesty, His heirs and successors should from time to time think fit to order and direct by any Proclamation or Proclamations to be issued for that purpose; in pursuance of which 'Act a Proclamation was on the twelfth day of July following, made and issued by His Royal Highness the

of His said Majesty, whereby, amongst other things, a scale of rates at which freights should be payable for public and for private treasure respectively, in peace and war and for different voyages, was fixed and established; and whereas We have thought fit to order that the said rates should be altered, We have, therefore, by and with the advice of Our Privy Council, deemed it expedient to issue this Our Royal Proclamation; and We do hereby ordain, declare, and command, that from and after the first day of September next, the said scale of rates so fixed shall cease and be no longer in force; and We do further declare, that from thenceforth the following rates shall be established during peace and war:

And it is further established and declared, that such freight shall be payable, clear of all deduction whatsoever; and that it shall be stipulated in the bill of lading, that the Captains and Commanding Officers of Our ships and vessels shall not be liable to any expences attending the shipment of such treasure or other articles, until the same shall be safe alongside of their respective ships or vessels; and that their liability shall cease from the moment they shall have landed the treasure at the port to which the ships carrying the treasure shall be destined.

And it is further declared, that in all other respects, save what is hereby altered, the said Proclamation of the twelfth day of July one thousand eight hundred and nineteen, and the rates and regulations thereby established, shall continue in full force.

Acts received the Royal Assent, April 22, 1831.

An Act for the support of His Majesty's Household, and of the honour and dignity of the Crown of the United Kingdom of Great Britain and Ireland.

An Act to indemnify such persons in the United Kingdom as have omitted to qualify themselves for offices and employments, and for extending the time limited for those purposes respectively until the twenty-fifth day of March one thousand eight hundred and thirty-two; to permit such persons in Great Britain as have omitted to make and file affidavits of the execution of indentures of clerks to attornies and solicitors, to make and file the same on or before the first day of Hilary Term one thousand eight hundred and thirty-two; and to allow persons to make and file such affidavits, although the persons whom they served shall have neglected to take out their annual certificates.

An Act to amend an Act, of the sixth year of His late Majesty, to regulate the trade of the British

possessions abroad.

An Act for enabling His Majesty's Postmaster-General to sell the premises lately used as the Post-Office, in Lombard street, Abchurch-lane, and Sherborne-lane, in the city of London.

An Act to alter and amend the several Acts now in force, for the assessing, collecting, and levying of county rates, so far as the same relate to the county of Middlesex.

An Act for better supplying with water the several hamlets of Beard, Ollerset, Thornset, and Whittle, in the parish of Glossop, in the county of Derby.

An Act for making the River Waveney navigable for ships and other sea-borne vessels from Rosehall Fleet to the mouth of Oulton Dyke; and for making and maintaining a navigable cut from the said River at Carlton Shares Mill into the said Dyke, leading to Oulton Broad, in the county of Suffolk.

An Act for amending and enlarging the powers and provisions of the several Acts relating to the

Liverpool and Manchester Railway.

An Act for better supplying with water the several townships of Hyde, Werneth, and Newton, in the county palatine of Chester.

An Act for embanking, draining, improving, and preserving certain fen lands and low grounds lying in the parish of Yaxley, in the county of Huntingdon, called " the Undrained Fen.

An Act to enlarge and amend the powers and provisions of the several Acts relating to the Birmingham and Liverpool Junction Canal, and to better supply the said canal with water.

An Act to consolidate and extend the powers and provisions of the several Acts relating to the navigation from the Trent to the Mersey.

An Act for making and maintaining a railway from the borough of Wigan to the borough of Preston, both in the county palatine of Lancaster, and collateral branches to communicate therewith.

An Act for taking down the parish church of Great Marlow, in the county of Buckingham, and for rebuilding the same on or near the present site

An Act for more effectually keeping in repair several roads in the county of Carmarthen, usually called the Llandovery district of the Lampeter roads;

and for making and maintaining certain new lines of road to communicate therewith.

An Act for more effectually keeping in repair the roads from Ludlow-fach to the town of Llandovery, and from thence to the River Amman, in the county of Carmarthen, and several other roads, in the said county, communicating therewith, and for making new branches of road in the same county, and in the county of Glamorgan.

An Act for maintaining the road from Enfield Chase, in the county of Middlesex, to Lemsford Mill, in the county of Hertford.

An Act for maintaining and improving the road from Titchfield to Cosham, in the county of South-

ampton.

An Act for more effectually repairing and improving the roads called "the Pucklechurch or Lower District of Roads," in the counties of Gloucester and  $\mathbf{W}$ ilts.

An Act for repairing the turnpike road from the Salutation Inn to Christian Malford-bridge, in the county of Wilts, called "the Draycot or Upper District," and for disuniting the said road from a certain other road called "the Pucklechurch Lower District," in the county of Gloucester.

An Act for more effectually repairing and keeping in repair the road from Carlowrie-bridge, on the River Almond, to Linlithgow-bridge, on the River . Avon, and other roads in the county of Linlithgow.

An Act for more effectually repairing the road from Bishopsgate-bridge, in the city of Norwich, to the Caister Causeway, in the county of Norfolk.

An Act for more effectually repairing several roads in and near the town of Bruton, and other roads in the counties of Somerset and Wilts, and for making and maintaining two other roads communicating therewith.

An Act for more effectually repairing, widening, and otherwise improving the road from the south east end of the town of Loughborough, in the county of Leicester, commencing at South Field-lane, to the south end of Cavendish-bridge, in the same county.

An Act for consolidating the trusts of the several turnpike roads in the neighbourhood of Cheadle, in the county of Stafford, and for making deviations and new branches to and from the same.

An Act to amend an Act, of the seventh and eighth years of His late Majesty, for the more effectually repairing and otherwise improving the roads in the county of Glamorgan.

An Act for more effectually repairing and improving the roads from Tunbridge Wells, in the county of Kent, to the Cross Ways at or near Maresfieldstreet, and from Florence Farm to Forest-row, in the county of Sussex.
