#### TOWN AND COUNTRY PLANNING ACT 1971

*The Stopping-up of Highways (Brynteg Lane, Brynteg Park, Beddau, Mid Glamorgan) Order*

The Secretary of State for Wales hereby gives notice that he has made the above Order under section 209 of the Town and Country Planning Act 1971 to authorise the stopping-up of the highway described in the Schedule to this notice to enable development to be carried out.

The Order requires the provision of a new road, which shall be a highway maintainable at the public expense, and for which Mid Glamorgan County Council shall be the highway authority.

Copies of the Order may be inspected free of charge at all reasonable hours at the offices of Taff Ely Borough Council, 11-11A Mill Street, Pontypridd.

If any person desires to question the validity of the Order, or of any provision contained therein, on the grounds:

- (a) that it is not within the powers of the Town and Country Planning Act 1971; or
- (b) that his interests have been substantially prejudiced by a failure to comply with any of the requirements of that Act

he may within 6 weeks of 17th May 1990, apply to the High Court for the suspension or quashing of the Order or of any provision contained therein.

### SCHEDULE

(all distances are approximate)

The lengths of highway to be stopped up are at Beddau in the County of Mid Glamorgan. They are shown as zebra hatching on the deposited plan and are those lengths of Brynteg Lane which extend:

- (1) from a point 45 metres south-west of its junction with Llantrisant Road in a general westerly direction for a distance of 80 metres.
- (2) from a point 215 metres south-west of its junction with Llantrisant Road for a distance of 60 metres. (1 SI)
