PETROLEUM AND SUBMARINE PIPE-LINES ACT 1975

Notice of the Issue of a Submarine Pipe-line Works Authorisation

ROAD TRAFFIC REGULATION ACT 1984

The M4 Motorway (Junction 19 Hambrook Interchange, Avon) (Prohibition of Traffic) Order 199

The Secretary of State for Transport hereby gives notice that he proposes to make an Order under sections 1(1) and 2(1) and (2) of the Road Traffic Regulation Act 1984, on the M4 Motorway at its Junction with the M32 at Junction 19, Hambrook Interchange near Bristol, Avon. The effect of the Order would be to prohibit traffic from proceeding on the M4 Motorway between the slip roads to and from the M32 Motorway.

Exceptions would be made for emergency vehicles or anything done with the permission or at the direction of a police constable in uniform.

A copy of the draft Order, which is accompanied by a plan illustrating the proposal and a statement explaining more fully the Secretary of State's reasons for proposing to make the Order, may be inspected during normal office hours at the offices of the Avon County Council, Avon House North, St James Barton, Bristol BS99 7SG; and of Northavon District Council, Council Offices, Castle Street, Thornbury, Avon BS12 1HF.
