Petersbourg, Dec. 17. Last Sunday Morning Felt Marshal Munich arrived here. His Excellency immediately waited on her Czarish Majesty, who received him very graciously.
Vienna, Jan. 4, N. S. On Wednesday last the Count de Fuenclara had Audiences of their Imperial Majesties, and notified to them the Marriage concluded between the King of the



two Sicilies and the eldest Princess of Poland ; and it is now publickly declared. Count Fuenclara is to go himself to Dresden to demand the Princess in Form. It is said that she will set out in the Month of March, and take the Road of Linz and Inspruck. The King of Poland is to have her conducted and defrayed to the Frontiers of Italy, where she is to be received and defrayed in the Name of the King her future Spouse. The Empress Dowager continues to mend every Day. All the Imperial Family, as well as the Great Duke of Tuscany, have visited her during her Sickness.

Berlin, Jan. 11, N. S. On Tuesday last the King of Prussia dined at General Ginkel's, the Dutch Minister here : The Day after was performed at the Castle, in the Presence of their Prussian Majesties, and of several Persons of Distinction who were invited on that Occasion, the Ceremony of the Marriage between M. Arnheim and the young Countess of Schulenburg, one of the Queen's Maids of Honour, and Daughter of General Count Schulenburg ; and on Thursday last his Prussian Majesty removed from hence to Potzdam, whither the Queen is also to go on Wednesday next : And the Court will continue there, as it usually does every Year, till the Time of the General Reviews.

Hambourg, Jan. 14, N. S. Major General Lofs, who was formerly in the Swedish Service, will succeed the late General Albedyl, in his Place of Commandant of this City. We have certain Advices from Copenhagen, that the King of Denmark will come to Alrena towards the latter End of April, and remain the best Part of next Summer in this Neighbourhood.
