

Census 2011

Summary for West Oxfordshire Including Carterton, Chipping Norton and Witney



The 2011 Census



The national Census was carried out on 27 March 2011 with results being released by the Office for National Statistics (ONS) from mid-2012 onwards.

Data from the Census survey gives an in-depth picture of the local population, housing, living arrangements and employment and is used by communities and public sector agencies to help plan local services.

Completing the Census form was mandatory and an estimated 97% of the households of West Oxfordshire district completed their questionnaire on paper or the internet (across England the return rate was 95%).


This leaflet provides a summary of the main findings of the 2011 Census survey for West Oxfordshire district and for the main towns of Witney, Carterton and Chipping Norton.

Further local area Census data is available for parishes, electoral wards and for smaller geographic areas including output areas covering an average of 150 households and super output areas of up to 1,200 households. See *Finding out more* at the end of this leaflet.

Who we are - the population of West Oxfordshire

As of March 2011, there were 104,800 people living in West Oxfordshire district. This was up from the total of 95,600 residents at the time of the last Census survey of 2001, an increase of just over 9,000 (+10%).

The growth in population has been located mainly in the towns of Witney and Carterton (see right hand chart below) which together accounted for 84% of the increase in the household population in West Oxfordshire.

Despite the increase in the size of the main towns, more than half (53%) of the population live in rural villages and, with a population density of 1.5 people per hectare, West Oxfordshire district is the second most sparsely populated of the 67 local authorities in south east England.

The older age group has increased significantly. From 1981 to 2011, the total population in West Oxfordshire increased by 28% (+23,100) while the population aged 60+ increased by 82% (+11,900).

In 2011, 2,740 people in West Oxfordshire were aged 85 or over, representing 2.6% of the total population - above the national average of 2.2%.


Who we are - in summary

Young people

There is a similar proportion of young people aged 0 to 15 in West Oxfordshire district (19%) compared with the regional and national averages.

The proportion of young people living in Chipping Norton is below average.

Outside the main towns 18% of people are aged 0 to 15, just below the district average.




Older people

The proportion of older people in West Oxfordshire district is above average. 18% of people are aged 65 and over compared with 16% nationally.

Witney and Carterton each have a below average proportion of older people and Chipping Norton is above average.


Outside the main towns 22% of people are aged 65 and over, well above the national average.



People from ethnic minority backgrounds

West Oxfordshire has a relatively low proportion of residents from an ethnic minority (non white British) background.

The largest ethnic minority group is "other white" which makes up almost half (46%) of the total ethnic minority population in West Oxfordshire.




Of the 8,486 people in West Oxfordshire who were born outside the UK, the largest populations from individual countries were from Poland (781 people), Germany (764), Ireland (599) and the United States (568). Europe in total was 3,915, Africa and Middle East & Asia each accounted for around 1,500 people.

Working age people with activities limited by health

West Oxfordshire's working age population is comparatively healthy with 9% of people aged 16 to 64 stating that their day to day activities were limited by a long term health problem or disability compared with 13% nationally.

Witney and Carterton had similar rates. Chipping Norton was above the district average




How we live - housing and living arrangements

As of March 2011, there were **43,200** households in West Oxfordshire district. This was up from the total of 38,400 households in 2001, an increase of 4,800 (+13%).

70% of households in West Oxfordshire were owner occupied, either fully owned or with a mortgage, above the national average of 63%.

There has been an increase in the number of households that are rented privately, from 14% of the total in 2001 to 17% in 2011. The proportion of private rented households in Carterton remains well above average.


Percent of households that are rented privately 2001 to 2011

Information about number of bedrooms was included for the first time in this Census survey.

West Oxfordshire has a lower than average rate of households with 1 or 2 bedrooms, 32% compared with 40% nationally.



Between 2001 and 2011 West Oxfordshire saw an above average increase in households occupied by pensioners living alone (+3% compared with -7% nationally) and in households occupied by lone parents with dependent children (+38% compared with +20%).



Car ownership

Over the past 30 years, between 1981 and 2011, the number of households in West Oxfordshire increased by just over 50% while the number of cars owned by residents has more than doubled.

The number of cars per household increased from 1.08 in 1981 to 1.52 in 2011.

The rate of 1.52 cars per household in West Oxfordshire is above the national average of 1.16.




What we do - economic activity and employment

Economic activity

In March 2011 West Oxfordshire had an aboveaverage rate of economic activity and employment.


77% of people aged 16 to 74 in West Oxfordshire were economically active (including full and part time employees, self-employed and unemployed) compared with 70% nationally.



Unemployment

Unemployment in West Oxfordshire at the time of the 2011 Census was below half the national average. 3% of the economically active population in West Oxfordshire were unemployed compared with 6.3% nationally. Unemployment in Witney was above the district average.

Of the 1,730 unemployed in March 2011, 29% (507 people) were in the age group 16 to 24, just above the national average of 28%.




Qualifications

People in West Oxfordshire are relatively well qualified.


A third (33%) of people aged 16+ had a degree or equivalent in West Oxfordshire district compared with 27% in England.

18% of people aged 16+ (just over 15,000 people) in West Oxfordshire had **no qualifications**, below the England average of 22%.



Occupation

An above average proportion of people were employed in professional or associate professional and technical occupations (33% compared with 30% nationally).

National Statistics policy is that estimates published for any geographical area are aggregations of whole output areas, the lowest geographical level for which census estimates are produced. This ensures that estimates can be released for any area which contains at least one output area, and contains the minimum population to ensure confidentiality (100 persons and 40 households). Some parishes in West Oxfordshire district have a very small population and have been assigned to a corresponding output area as noted in the table above.

^{**} Communal establishment residents of RAF Brize Norton were counted in the parish of Brize Norton in 2001 and are now counted in Carterton parish. This change mainly affected the population in the age range 18 to 45 and will affect the population base in many tables when making comparisons between 2001 and 2011 for these parishes.
