WHEREAS, the first Portuguese settlers arrived in Hawaii over one hundred years ago in September, 1878; and

WHEREAS, close ties of friendship have developed between the people of Portugal and the people of Hawaii since 1878; and

WHEREAS, the establishment of a sister-city relationship between Honolulu and a major city in Portugal would be fitting recognition of the centennial of the arrival of the Portuguese in Hawaii and of the warm relationship between the Portuguese people and the people of Hawaii; and

WHEREAS, a logical choice for a sister-city in Portugal would be Funchal, capitol of the Madeira Islands, from which the first large group of Portuguese embarked for Hawaii; and

WHEREAS, Funchal bears a striking resemblance to Honolulu in that both are capitol cities and major ports. Also, the Madeira Islands, like the Hawaiian Islands, are volcanic in origin and the topography and climate of Funchal and Honolulu are remarkably similar; and

WHEREAS, the government of Portugal has indicated that it would look with favor upon the establishment of a sister-city relationship between Honolulu and a major Portuguese city; now, therefore,
