## RESOLUTION

**ESTABLISHING A SISTER-CITY RELATIONSHIP WITH CEBU CITY, PROVINCE OF CEBU, REPUBLIC OF THE PHILIPPINES.**

WHEREAS, on November 22, 1989, the Council adopted Resolution 89-63, CD-1, which extends an invitation to the municipal officials and people of Cebu City to establish a sister-city relationship with the City and County of Honolulu; and

WHEREAS, the Sangguniang Panlungsod of Cebu City has responded to the invitation, adopting Resolution No. 1530 on November 27, 1989; and

WHEREAS, Resolution No. 1530 authorizes the Mayor of Cebu City:

. . . to sign and enter into an agreement for the establishment of a sister-city relationship with the City of Honolulu to promote international friendship and understanding, to carry on exchanges and cooperation in the areas of business and trade, agriculture and industry, tourism, sports, health, social welfare and other fields of human endeavor for the mutual benefit of both cities to achieve lasting peace and prosperity;

and

WHEREAS, the Council is in full agreement with the objectives of the sister-city relationship, as expressed by the Sangguniang Panlungsod; now, therefore,

BE IT RESOLVED by the Council of the City and County of Honolulu that this body approves the establishment of a sister-city relationship between the City and County of Honolulu and Cebu City, Province of Cebu, Republic of the Philippines; and

BE IT FURTHER RESOLVED that the Mayor of the City and County of Honolulu is requested and authorized to sign and enter into an agreement with the Mayor of Cebu City to formalize the relationship; and
